<u>HB 1510</u> <u>Status</u>	RELATING TO HEALTH. Amends provisions relating to the care of the elderly and disabled in state-licensed care facilities.	HUS/HLT, FIN
<u>HB 93</u> <u>Status</u>	RELATING TO MEDICAID. Establishes an add-on payment of forty per cent to the medicaid base rate for medicaid enrollees at long-term care facilities that have medically complex conditions requiring higher level of care. Appropriates funds for fiscal years 2018 and 2019 to cover increased costs.	HUS/HLT, FIN
<u>HB 1272</u> <u>Status</u>	RELATING TO IMPROVING ACCESS TO PSYCHIATRIC CARE FOR MEDICAID PATIENTS. Specifies that coverage for telehealth under the State's medicaid managed care and fee-for-service programs includes psychiatric services provided through a coordinated care manager who is present in a primary health care provider's office through telehealth.	HUS/HLT, FIN
<u>HB 1008</u> <u>Status</u>	RELATING TO MENTAL HEALTH. Requires DHS and DOH to deem occupational therapists as qualified mental health care professionals.	HUS/HLT, IAC/CPC

Directs DHS to develop and implement residential campgrounds for the homeless.
