<p><u>HB 208, HD2</u> (HSCR965) Status & Testimony</p>	<p>RELATING TO LABOR. Authorizes the Director of Labor and Industrial Relations or the Director's designee to issue and serve on an employer a stop-work order prohibiting the use of employee labor by the employer until the employer complies with certain provisions regarding security for payments of compensation to employees. Establishes penalties, enforcement, and protest procedures related to stop-work orders. (HB208 HD2)</p>	<p>JDL, WAM</p>
<p><u>HB 279, HD1</u> (HSCR792) Status & Testimony</p>	<p>RELATING TO CAMPAIGN CONTRIBUTIONS AND EXPENDITURES. Specifies that certain types of dissemination, distribution, republication, and use of campaign materials or the financing of such by any person shall not be considered a contribution to a candidate. (HB279 HD1)</p>	<p>JDL</p>
<p><u>HB 280, HD1</u> (HSCR793) Status & Testimony</p>	<p>RELATING TO CANDIDATE COMMITTEE REPORTS. Clarifies the due dates of preliminary, final, and supplemental reports to be submitted to the Campaign Spending Commission and provides that the supplemental report due on January 31 must be filed every year. (HB280 HD1)</p>	<p>JDL</p>
<p><u>HB 281, HD1</u> (HSCR794) Status & Testimony</p>	<p>RELATING TO THE FAILURE TO FILE A REPORT WITH THE CAMPAIGN SPENDING COMMISSION. Requires the Campaign Spending Commission to publish on its website the names of all noncandidate committees that fail to file a report or to correct a report within the time allowed by the Commission. (HB281 HD1)</p>	<p>JDL</p>
<p><u>HB 282, HD1</u> (HSCR795) Status & Testimony</p>	<p>RELATING TO CAMPAIGN SPENDING. Clarifies that increased fines may apply if a noncandidate committee fails to timely file a second preliminary general report. (HB282 HD1)</p>	<p>JDL</p>

RELATING TO ELECTION CAMPAIGN REPORTING.
Requires a candidate or noncandidate committee to inform the Campaign Spending Commission if the candidate or noncandidate committee does not intend to receive or spend contributions and expenditures that aggregate more than \$1,000 in an election period. (HB289 HD1)
