HB 437, HD2 (HSCR1040) Status & Testimony	RELATING TO COASTAL ZONE MANAGEMENT. Prohibits variances for installation of shoreline hardening structures in shoreline areas, unless a public hearing is held, the applicant demonstrates that the shoreline hardening structure is necessary to protect an existing legal object, structure, or activity from damage due to seawater inundation or shoreline erosion, and no reasonable alternative locations exist. (HB437 HD2)	WTL, JDL
HB 861, HD2 (HSCR1078) Status & Testimony	RELATING TO COMMUNITY-BASED SUBSISTENCE FISHING AREAS. Establishes a goal for the Department of Land and Natural Resources to designate and adopt rules for the management of no fewer than five community-based subsistence fishing areas by December 31, 2025. Establishes designation process and rule requirements. (HB861 HD2)	WTL, WAM
