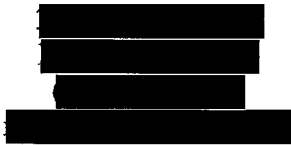



To serve as a member of the E911 board in an effort to assist in assuring effective 9-1-1 services to the island of Kaua'i and State of Hawai'i.


