In my capacity as a Clubhouse generalist, I have had the pleasure of working with Angela as her primary staff for 5 years. She has assisted me with many projects ranging from baking cookies to writing grants, and creating excel spreadsheets for statistical purposes. She was also employed for 2 years in a very challenging job with a challenging employer and she was able to appropriately cope with the many stressors of the job and also appropriately sought assistance from staff when needed. And although her employer could be quite demanding and intimidating at times, Angela was able to stand firm on issues she believed in.

Angela has skills in many areas. She is intelligent, articulate, patient, has a great sense of humor, learns quickly, and is dependable, reliable and responsible with all that she undertakes. She also displays a real commitment to all projects she gets involved in, often doing research on her own to be able to do the best job possible (ie; has borrowed books on grant-writing and excel spreadsheets while working on particular projects). Angela's only potential weakness is her soft voice. During group activities, it can be difficult to hear her, but she is also able to project her voice when needed.

Angela has been working as a personal assistant for a Clubhouse member who recently went blind. She accompanies the blind member to her instructional sessions with the blind coach and then reinforces what was learned through working with the member to complete independent living tasks such as meal preparation, light housekeeping, and sorting through the mail. Although she has been a paid personal assistant to this member for only about a year, she and the member were friends when the member first went blind, and Angela's support has helped the member cope with the many emotions (ie; anxiety, fear, frustration, anger, etc.) that come with the frightening aspect of going blind.

I feel that Angela would make a great asset to the Kauai Service Area Board.
