During this period where the WDC mission is to closer integrate the needs for a qualified work force, identifying available workforce skills and available, or necessary, training programs, MGen Richardson will bring much needed expertise and personal contacts to the "Military to Civilian Transition Program". The area of Cyber security is a top priority in many organizations, and many of our exiting Military Veterans have acquired great skills that are being sought by private sector companies.

Most recently, I worked with MGen Richardson is establishing a partnership between Private sector (BAE Systems and Ship Repair Association Hawaii), and State (Hawaii Community College / Workforce Development Division) to train needed welders for the Hawaii maritime industry. All of the apprentice welder trainees were secured from the National Guard's "Youth Challenge Academy" Program, which MGen Richardson established during his term as Hawaii's Adjutant General. The first HCC graduating class of welders produced 3 graduates who are now fully employed by the Ship Repair industry. The second HCC class, currently has 10 YCA cadets in training, with expectations that all will be employed by the Ship Repair industry after successful graduation. This has been a very successful Private-Public Partnership, with MGen Richardson being a big part of the success.

I fully support the appointment of MGen Edward Richardson, and respectfully ask your positive appointment confirmation action.
