Kathleen Hagan: Health Planning Council, Tri-Isle Subarea

(1) Why do you want to be a member of the Board?

I would like to continue to bring my diverse knowledge and experience in health care to a role where I can impact health planning in my community. My passion is health promotion in all of its forms, and I would like to help make the most impactful and sustainable use of scarce resources in our island community to optimize the health of current and future residents.

(2) What do you perceive are the roles and responsibilities of a member of the Board?

I have served on this board since July, 2016 (finishing a departing member's term) so I have a sense of the schedule and expectations. My understanding of the roles of the Subarea Health Planning Councils (SACs) include review of Certificate of Need (CON) applications and provision of recommendations pertaining to health planning in my area (tri-isle: Maui, Molokai, Lanai). Responsibilities would include participation in meetings, review of reports and papers, discussion and collaboration, and production of decisions and recommendations.

(3) In what ways do you feel that you can help protect the consumer?

I think I can help protect the consumer by being part of a process that critically analyzes the potential costs and benefits of proposals/plans and make sure that overall they serve the consumers. I think the ethical principles that guide my professional Nursing practice- including autonomy, fidelity, beneficence, non-maleficence, and justice- will serve me well in making these judgments. I also am a healthcare consumer myself (as an individual, an employee, a family member) and have that perspective as well as that of a health care provider.

(4) Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

I bring experience from a variety of health care areas. I have worked in health promotion, pricing, programming/data analysis, epidemiological and health services research, inpatient nursing, and outpatient nursing, and education. I have been involved in service for our Maui County community members across the lifespan, from acting as the nurse for the Tutu & Me Traveling Preschool program, to precepting nursing students in asthma screening and education in the grade schools, to serving as a judge at Health Occupation Student Association events at the high school level, to serving college students by providing health

clearances and reproductive health services at the UHMC Health Center, to providing vaccinations to our older population at the Senior Fair. I have strong analytical skills and am comfortable working with numbers and statistics, and also get along well with people. I have had formal leadership training and tend to be visionary, but also have strong attention to details. I appreciate that there are diverse perspectives on almost any issue and healthcare is complex and dynamic; at the same time, we have to, as my first employer taught me, to make decisions on "best data available."

(5) What do you hope to accomplish during your term of service

I don't have a particular agenda; I simply hope to listen, learn, and participate to continue to better understand the health needs and opportunities in our community, and to bring to bear my knowledge, experience, and skills to help the council make the best decisions and recommendations possible to match these needs and resources. As a resident, parent, consumer, educator, and passionate health promoter, I hope to improve the health care of Hawaii's citizens, leaving them more healthy (or at least with the potential and services to achieve better health) than when I began.

(6) Name three qualities that best describe you and how these qualities will benefit the Board.

<u>Analytical</u>: I am comfortable working with numbers and data and enjoy critically evaluating proposals and presentations to guide decision-making. This will aid in the process of reviewing CON applications.

<u>Dedicated</u>: When I commit to something, I give it my time and energy to achieve high standards. I am thorough and would be so with the duties of the Board. <u>Cooperative</u>: As both a teacher and a nurse I work as part of a team and get along well with others. It is in my nature to help others and bring out the best performance in individuals as well as teams. This will be helpful in working with fellow Board members in discussions and decision-making processes.

(7) Name a previous experience you've had that will be beneficial as a Board member.

An ongoing experience I am involved in that continues to be a great learning experience has been the procurement (including identification of a health need and application for a grant) and execution of a grant to pursue a Smoke-free UHMC. The process has involved healthy policy research, development of a budget, writing of a grant proposal, assembly of a Task Force, promotional work, survey development, policy development, and event planning, to name a few key parts. Of course, I haven't done it alone, so it has involved recruitment, networking, and collaboration to mobilize the expertise and interest of all components of the college community to support the efforts. I feel these research, planning, writing, and collaborative experiences, as well as the experience of

maintaining respectful interactions with those who disagree with strongly held views of mine, will all enhance my ability to contribute to the challenging work of the board.

(8) Can you foresee any possible conflicts of interest that could arise during your service on the Board? How would you overcome conflicts of interest?
