Rosanna Daniel-Kanetake: Disability and Communication Access Board

(1) Why do you want to be a member of the Board?

To increase knowledge in the community of ADA rights and accessibility to places and opportunities for persons with disabilities that is afforded others.

(2) What do you perceive are the roles and responsibilities of a member of the Board?

Educate and advocate the laws of the ADA and where there are issues or noncompliance of ADA standards, work collaboratively in an attempt to resolve or address the issues.

(3) In what ways do you feel that you can help protect the consumer?

My education, professional experience, and personal life skills as a person with a disability, I know the obstacles and barriers consumers go through in their attempts of being an active and contributable member in the community.

(4) Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

I have a Bachelor's degree in Social Work, a Masters in Psychology. I have worked in various human service fields for 20 plus years. The people I have worked with and for, come from all walks of life, every socio-economic background, and afflicted with many different types of disabilities. I am driven and have a passion to contribute to social changes that will enhance the lives of persons with disabilities who strive to be contributing members of the community by having equal access and opportunity.

(5) What do you hope to accomplish during your term of service

To establish working relationships with others of like mind that will help address issues and barriers in the community that block or inhibit persons with disabilities from participating in community life and employment.

(6) Name three qualities that best describe you and how these qualities will benefit the Board.

- 1) I am a very independent & determined individual. When others say a resolution is not possible, I don't quit till a solution is found.
- 2) I have always been known for "thinking outside the box". When a

conventional method of doing something is not possible, I am able to come up with ways of completing or achieving a goal, that may be unusual but the end result is the desired result.

3) I am very caring and empathetic to all individuals who desire and strive for equality, independence and success and will go out of my way to assist them in achieving their goal.

(7) Name a previous experience you've had that will be beneficial as a Board member.

I was born with disabilities but the first half of my life they were hidden from hose outside my family. Then I was suddenly stricken with an illness that exacerbated the disabilities I had fought to keep secret or private from the public and employers and had to undergo extreme medical treatment and 2 brain surgeries that resulted in 6 years of endless physical therapy and Traumatic Brain injury classes and groups. Finally when I was well enough to return to work, I soon realized that other people's opinion and ideas of "not being fully functional" because now I am in a wheelchair and had undergone 2 brain surgeries, that I would not or could not be a beneficial team member to the agency. I was turned down for many positions from old employers who I had successfully worked with me in the past, before my illness. Often when I would try to apply at new agencies who advertised as Equal Opportunity Employers, there was no wheelchair accessibility to the office. Or I would be handed a disclosure form and told, "This disability disclosure form is voluntary, but is strongly recommended you fill it out". From the point of view of someone in a wheelchair to even be asked to fill out that form is very humiliating and self-defeating.

(8) Can you foresee any possible conflicts of interest that could arise during your service on the Board? How would you overcome conflicts of interest?

I can see no conflicts of interest at this time.
