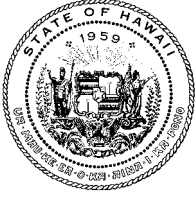

As an active Hawai'i resident and the Regional Director of American Medical Response who is knowledgeable about the complex issues involved in health planning and coordination in our State, I am committed to the important role of the Statewide Health Coordinating Council.

The SHPDA board primarily assists in the review of the health needs of the State, to include costs and facilities. Board members promote shared facilities and services in order to achieve economies of scale and ensure appropriateness of care.
