In consideration of **GOVERNOR'S MESSAGE 662** SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE BOARD OF LAND AND NATURAL RESOURCES GUBERNATORIAL NOMINEE, KEITH K. DOWNING, FOR A TERM TO EXPIRE JUNE 30, 2021.

Governor's Message 662 submits the Governor's nomination of Keith "Keone" Downing for an atlarge seat on the Board of Land and Natural Resources (Board). The Department of Land and Natural Resources (Department) strongly supports this nomination.

Mr. Downing is the son of big-wave pioneer, George Downing, a founder of Save Our Surf Foundation. He is a prize winning big-wave rider and paddler who has been surfing since the age of five. Today, he carries on the surfing tradition by taking his young grandson surfing weekly.

As part owner, with his sister, of Downing Hawaii, Hawaii's oldest surf shop, Mr. Downing is well aware of the financial importance of Hawaii's beaches and ocean recreation industry. He understands the fine balance between the need for regulations and encouraging certain kinds of businesses at Hawaii's landmark beaches and ocean recreation areas.

Mr. Downing was first nominated to the Board in 2015 and he has brought his passion, knowledge and respect for the ocean to Board decisions ranging from fireworks at Waikīkī to seawalls in Lāhainā. He also understands the need for ocean education. As a member of the Surfing Education Association, Mr. Downing is dedicated to the preservation of Hawaii's oceans, coral reefs, waves and beaches. Mr. Downing brings all of this knowledge and family tradition to bear on Board Decisions, often providing the Board a different perspective from which to view an issue.

The Department strongly supports Mr. Downing's nomination to the Board of Land and Natural Resources.
