In consideration of **GOVERNOR'S MESSAGE 663** SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE BOARD OF LAND AND NATURAL RESOURCES GUBERNATORIAL NOMINEE, SAMUEL GON III, FOR A TERM TO EXPIRE JUNE 30, 2017.

Governor's Message 663 submits the Governor's nomination of Samuel Gon III for the O'ahu seat on the Board of Land and Natural Resources (Board). This nomination is to fill the vacancy caused by the resignation of Ms. Ulalia Woodside. Dr. Gon's training and background also meet the requirements for the expert in natural resources and Hawaiian traditional and customary practices. The Department of Land and Natural Resources (Department) strongly supports this nomination.

Dr. Gon was first nominated to the Board in 2006 and served two four-year terms. He stepped down in 2014 and is therefore eligible to serve two more four-year terms. The Department is pleased to welcome Dr. Gon back so that we may benefit from his broad knowledge of natural and cultural resources in Hawai'i.

Dr. Gon is the Senior Scientist and Cultural Advisor for The Nature Conservancy in Hawai'i. He has over 35 years of experience in Hawaiian ecology, including biological inventory and research, field ecology, ecological modeling and biological database management. Dr. Gon is also a Kumu Hula and is proficient in the Hawaiian language. He is able to combine the two to provide a cultural lens to the Department's mission to:

Aloha Senators Rhoads and Gabbard,

It is my pleasure to support the nomination of Dr. Sam Gon III to the Board of Land and Natural Resources (GM 663 and GM 664). I have known Sam for almost 40(!) years, ever since we were both undergraduates at the University. During every school break Sam and I and a group of like-minded folks went on volunteer service projects in the Hawaiian backcountry for the Hawai'i Service Trip Program. We built fences to keep goats and pigs out of sensitive ecosystems, built trails to improve public access to scenic areas, and eradicated invasive plants. Over the years, Sam participated in, or led, probably a few 10s of these trips. They require physical and mental fortitude to deal with challenging terrain and vegetation, and to live in sometimes primitive backcountry campsites. Why this is relevant to Sam's appointment to the BLNR is that most of all these trips require strong dedication to the Hawaiian environment because the work is difficult and all volunteer!

Sam is one of those rare people on which one can confer the title of genius. He is skillful at anything he tries – science, music, `ōlelo Hawai`i, the intricacies of land policy, and most importantly, how these and many other aspects of Hawai`i nei are inter-related. Because he is so smart, clever, and fair-minded, Sam will be a very valuable asset to the Board, especially when they need to make difficult or contentious decisions. Sam is one of very few people who combine deep knowledge of both the western and Hawaiian viewpoints of our ecosystem, and the BLNR will be fortunate to have Sam's expertise.
