In consideration of GOVERNOR'S MESSAGE 669 SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE LEGACY LAND CONSERVATION COMMISSION, GUBERNATORIAL NOMINEE, WILLIAM HAASE, FOR A TERM TO EXPIRE 06-30-2020

The Department of Land and Natural Resources (Department) strongly supports Governor's Message (GM) 669, nominating Mr. William Haase to the Legacy Land Conservation Commission (Commission) for a term to expire June 30, 2020.

Mr. William "Butch" Haase resides on Moloka'i and possesses membership in a land conservation organization organized in the State, thus fulfilling the Commission membership requirements of Sections 173A-2.4(a) and -2.4(a)(3), Hawai'i Revised Statutes.

Mr. Haase is currently serving an interim appointment that began in fall 2016, and he was an attentive and insightful participant in the Commission's review and recommendation process for Fiscal Year 17 applications to acquire land for public benefit. As a professional who manages lands for conservation purposes; directs the operations of a local land trust; and leads successful applications and acquisitions through the Legacy Land Conservation Program (LLCP) process, Mr. Haase is well-aware of the challenges faced by the LLCP and constituent nonprofit land conservation organizations. Most importantly, he thinks creatively and strategically about alternatives for overcoming these challenges, as demonstrated by the recent allocations to a Moloka'i Land Trust venture from the New Market Tax Credits program.

Mr. Haase's experience with land trust operations and financing is a welcomed strength. He engages deeply and directly with the issues raised by applicants, Commissioners, and staff.

The Department strongly supports GM 669 and recommends that the Senate confirm the appointment of Mr. William Haase for a two-year term on the Legacy Land Conservation Commission.
