## Confirmation of Gubernatorial Nominee Dr. Christopher Kaliko Baker to the Kaho'olawe Island Reserve Commission

Aloha e Chairperson Karl Rhoads, Vice-Chairperson Mike Gabbardn and members of the Senate Committee on Water and Land. Dr. Baker has been a kumu of Hawaiian Language at the University of Hawaii at Mānoa Kawaihuelani Center for Hawaiian Language since 2002. He is a leader in the movement to perpetuate our Hawaiian language and has hosted Protect Kahoʻolawe 'Ohana Hawaiian Language Immersion huaka'i or accesses to Kahoʻolawe.

The Protect Kaho'olawe 'Ohana enthusiastically supports the re-appointment of Dr. Christopher Kaliko Baker to the KIRC.

## GOVERNOR'S MESSAGE 679 – SUBMITTED FOR CONSIDERATION AND CONFIRMATION TO THE KAHOOLAWE ISLAND RESERVE COMMISSION, GUBERNATORIAL NOMINEE CHRISTOPHER KALIKO BAKER

Governor's Message No. 679 nominates Christopher Kaliko Baker to serve on the Kaho`olawe Island Reserve Commission (KIRC) in the seat reserved for a representative of the Protect Kaho`olawe `Ohana (PKO). On behalf of the Commission, I wish to express <u>my strong support</u> and recommend his confirmation.

A graduate of Castle High School and the University of Hawai'i at Mānoa (UHM), Commissioner Baker is a PhD candidate in Linguistics and an instructor of Hawaiian at UHM's Kawaihuelani Center for Hawaiian Language. As a long-time member of the PKO, Kaliko has been part of Kaho'olawe's history from the Navy's return of the island to its transition to State management of its natural and cultural resources. In addition, he brings to the commission his expertise in Hawaiian language and Hawaiian cultural traditions as a noted Hawaiian language playwright and lead cultural practitioner for the *makahiki* ceremony on Kaho'olawe.

Commissioner Baker has been serving as a member of the KIRC since his initial appointment on May 13, 2011. Since that time, Commissioner Baker has taken on the role of guiding and expanding the cultural use of the Reserve.

Commissioner Baker's dedication to perpetuating the native Hawaiian language and culture is in alignment with the KIRC's vision for Kaho'olawe; "where the people of Hawai'i cares for the land in a manner which recognizes the island and ocean of *Kanaloa* (an ancient name for Kaho'olawe) as a living spiritual entity. Kanaloa is a *pu'uhonua* (place of safety) and *wahi pana* (storied place) where Native Hawaiian cultural practices flourish."
