#### (1) Why do you want to be a member of the Board?

Serving as a representative from Maui to the HHSC Board of Directors would allow me to contribute to the medical delivery system of Hawaii, using my experience and expertise in health care in positive ways.

## (2) What do you perceive are the roles and responsibilities of a member of the Board?

It is my belief that HHSC has been tasked with overseeing and collating the 5 regional hospital systems to share knowledge, provide a sounding board for interregional problems and solutions, and allow for centralized resources where applicable. Each board member should represent their region while keeping an open mind and mindset toward statewide concerns and interests. Not an easy task, I must say, but one that has the potential to move the entire statewide delivery system forward without restricting regional autonomy.

#### (3) In what ways do you feel that you can help protect the consumer?

Improving the state's hospital system will help all of the consumers who rely on it's services for their health care.

I would hope to facilitate communication between the regions/program office to assure the continued delivery of high quality hospital/LTC to all who depend on HHSC facilities.
