The Department of Land and Natural Resources strongly supports Governor's Message 717, nominating Dr. Norine Hayes to the Natural Area Reserves System Commission (Commission) for a four-year term to expire June 30, 2021.

Dr. Hayes is being nominated to serve on the Commission pursuant to Section 195-6, Hawaii Revised Statutes, as a person possessing scientific qualifications as evidenced by an academic degree in wildlife or marine biology, botany, forestry, ecology, resource management, biogeography, zoology or geology.

A 2003 graduate from the University of Hawaii with a Bachelor of Science in Zoology, Dr. Hayes received a Master of Science from the University of Hawaii in Zoology with a specialization in Ecology, Evolution, and Conservation Biology Specialization, and a PhD in 2010 under the same specialty.

Dr. Hayes has focused her professional life on the systematics of Hawaiian land snails and has a broad range of publications on a number of subjects. She is also engaged in the integration of science, policy and management with developing educational curricula that bridge the gap between science and public outreach to support stronger focus by both the public and management agencies on present day conservation issues.

The Department urges this Committee's favorable consideration on the nomination of Dr. Norine Hayes to serve on the Natural Area Reserves System Commission.

I fully support Dr. Norine Hayes' nomination to serve on the Natural Area Reserves System Commission. I have known Dr. Hayes since she took my Wildlife and Plant Conservation course a over 13 years ago as an undergraduate student at UH Manoa. I was her undergraduate advisor as well as her Ph.D. advisor. During nearly four decades of advising graduate students and serving on graduate committees, I have never known another student to progress so rapidly in her highly successful academic career. "Energetic" doesn't begin to describe her work ethic.

Since she graduated Dr. Hayes has worked as a Malacological (snails, etc.) Reserarcher at the Bishop Museum, and before that as a postdoctoral fellow in the Center for Conservation Research and Training. She has been very productive in a number of ways. Her CV will show research publications and other activities in detail. Although she is a successful and well-published scientist, she is absolutely terrific at community outreach. She can talk to all ages of people about all sorts of scientific and natural resource management topics in ways they can understand. She can make snails and slugs fun if anyone can!

Since finishing her Ph.D., Dr. Hayes has become an expert on Hawaii's native terrestrial snails the little guys we don't often hear about. Dr. Hayes collaborates with scientists at the National Museum of Natural History, and has traveled to Europe to work with mollusc collections in several museums. During the last several years, she has regularly worked at Bishop Museum studying extisting collections as well as contributing specimens from the work in which she is currently involved. She and her colleagues have discovered a number of new, some cryptic, species of terrestrial molluscs in Hawaii and have "rediscovered" a number of species thought to be extinct. Very exciting work! As a graduate student Dr. Hayes was awarded an NSF Graduate Teaching Fellowship. For two years she worked with elementary school teachers and students, as well as educational programs at the University's Lyon Arboretum. Teachers had high praise for her curriculum development skills as well as her ability to interact and reach elementary school children, including special education students. Dr. Hayes has also orgaized a number of community outreach workshops focusing on terrestrial mollusc identification and ecology for scientists as well as the general public. She is passionate about native mollusc conservation and has devoted a portion of her research time to helping with better management of these species and their habitats.

In sum, Dr. Norine Hayes is ideally qualified to serve on the Natural Areas Commission. Her excellent rapport with the public, her scientific work and her dedication to conservation and management are outstanding. She is one of the hardest working people I know.

In the 1970s I served a four-year term on this Commission and I have represented the University of Hawaii on the Commission since 2002, so I have a lot of experience and a solid appreciation for the Natural Area Reserves System, its importance to the people of Hawaii, its accomplishments, its staff, its challenges. I am happy to recommend Ms. Norine Hayes to represent Malacological (snails and slugs) interests on the NARS Commisison. I have known Nori and her family since about 2004 when she was a graduate student in Zooloogy at UH Manoa, the same Department I was an undergraduate and graduate student in. Like me, as a student, she was unsure of what direction she would go in with her degrees. I switched to Entomology in Tropical Agriculture and she gravitated from Ornithology to Malacology.

Once she became interested in terrestrial molluscs, her career was charted, she has not looked back, and Hawaii has been the rewarded benefactor. Work by her and others has immensely expanded our knowledge of the taxonomy and biology of both native and alien terrestrial molluscs in this State. Thanks to people like her, Rob Cowie and Ken Hayes, Malacology in Hawaii has really had new life breathed into it. A kind of renaissance of snails and slugs, if you will. As in the current taxonomy of many Families of plants and animals, DNA work by these researchers has revealed many cryptic species, revised phylogenetic relationships within native and alien mollusc taxa, and errors in previous misdentifications.

Besides her pioneering taxonomy work, she has paid her dues in the field, collecting snails and slugs (or tissue thereof) in both native habitats as well as plant nurseries. She received funds from USDA-APHIS to inventory molluscs in nurseries Statewide, where molluscs are significant pests as well as biosecurity threats from newly imported plants, and are also threats to other States that receive plants from Hawaii. If we send nursery plants to California with snails or slugs they don't want, they can reject an entire shipping container. It is very much an economic issue.

She has even been involved in field work on slugs as hosts of rat lung worm (*Angiostrongylus cantonensis*) The serious human health threat that worm causes Statewide and particularly here in Puna, has just been in the news (again) this past week. She assisted with snail identification, and did the first "screening" of those for rat lung worm.

In native habitats, she has gained permits from both DOFAW and NARSC to research native land snails and sample their DNA in both Forest Reserves and NARS so is familiar with those processes. Of all the threatened and endangered fauna in this State, snails, (like native birds) have lost most of their biodiversity and so need all the help they can get. Nori is one of those very few qualified to help. She has worked closely with NARS staff and understands how the NAR System works and what its needs are. I was a NARS Commissioner myself before I retired.
