Then he served as the Hawaii State Geologist with the Department's Commission on Water Resource Management. He participated in the Hawaii State Civil Defense Earthquake Advisory Board, Lava Flow Mitigation Technical Committee, and the Tsunami Advisory Board. Since his retirement in 2005, he has worked as a self-employed geologist.
