<u>TESTIMONY:</u> <u>Governor's Message No. 795: Relating to the Nomination</u> <u>of Kamanamaikalani Beamer</u> to the Commission on Water Resource Management ("CWRM")

Aloha Senators:

Po'ai Wai Ola of west Kaua'i strongly supports the Governor's nomination of Kamanamaikalani Beamer to serve a second term as Commissioner with CWRM.

We are a community that is closely linked to the west Kaua'i watersheds – including for the cultivation of our taro and food. The waters of the Waimea River are the focal point of the historic Waimea River valley that is home and sustenance to many generations of our Hawaiian families and specific species of fish and wildlife that depend on a healthy run-of-the-river. Kamanamaikalani Beamer has been open to hearing our concerns about local water issues, and understands the importance of restoring waters back to our rivers.

Aloha kākou,

My name is Lilikalā Kame'eleihiwa and I am the current diretor of the Kamakakūokalani Center for Hawaiian Studies at UH Mānoa where I am also a senior professor. Today I am writing in **strong support** for the nomination of Dr. Kamana Beamer for a second term on the State Water Resource Management Commission.

Professor Beamer is an expert on Hawaiian Ancestral Knowledge regarding Hawaiian water management practices. As you know our Hawaiian ancestors cultivated thousands of acres of Lo'i Kalo, or wet land taro terraces, because they discovered that an acre of wet land taro can feed 10-15 times more people than an acre of dry land taro. They were brilliant in their use of surface water management for this purpose.

Our Hawaiian ancestors were also excellent managers of underground water resources. On O'ahu alone as late as the 1880's there were 113 freshwater fishponds fed by underground springs comprising nearly 4,000 acres, raising 1 million pounds of fish per year for an ever increasing Hawaiian population.

Professor Beamer teaches classes at the Kamakakūokalani Center for Hawaiian Studies on traditional and modern methods of managing water and chairs graduate committees for advanced students engaged in research on Hawaiian water management. He is a foremost scholar in the field and I cannot imagine a better candidate for the State Water Resource Management Commission. I recommend him to you most highly and without reservation.
