The Department of Land and Natural Resources (Department) supports Governor's Message 809, nominating Ms. Leiana Robinson to the Island Burial Council, Islands of Kaua'i and Ni'ihau expiring June 30, 2021.

The Island Burial Councils are established under Section 6E-43.5, Hawai'i Revised Statutes. The Councils determine whether to preserve or relocate previously identified native Hawaiian burial sites, recognize lineal and cultural descendants, and provide counsel and advice to the Department.

Ms. Robinson was born and raised on the island of Ni'ihau. This allows her to provide a unique perspective to the council's deliberations as someone who was reared in a predominately full-blooded native Hawaiian community. In addition, Ms. Robinson's first language is her mother tongue. Ms. Robinson currently serves on the Kaua'i and Ni'ihau Islands Burial Council and she remains committed to continuing that service to her people.

Senate confirmation will ensure that Ms. Robinson's knowledge and perspective informs the deliberations of the Kaua'i and Ni'ihau Islands Burial Council until June 30, 2021.
