My name is Glenn Hong, and I am President of Young Brothers, Limited, an inter-island cargo common carrier. Since May of 2012, I have had the honor of serving on the State of Hawai'i Board of Agriculture, following Senate confirmation.

My interest in the agricultural industry stems from the economic, societal and environmental impacts that a sustainable agricultural industry should have on Hawai`i's future. The Hawai`ian Islands have a great challenge in its isolation, yet this also presents its own opportunities. Island communities are unique and Hawai`i is especially so. This is a very positive trend toward increasing food security and sustainability for Hawai`i and is consistent with the State of Hawai`i's goal of progressively producing a greater portion of its food consumption. Greater home grown production will shorten the supply chain from farm to table, significantly enhance nutrition through greater freshness, and result in reduced waste.

I support a robust agricultural industry, based on product diversity and entrepreneurship, employment growth, agricultural land preservation, watershed protection, and broad-based community development. I would like to support our agriculture programs which show promise for achieving such a sustainable vision. A clear vision and establishment of underlying objectives are necessary to ensure that our agricultural policies are effective. Objectives such as stopping harmful invasive species from entering the state require effective policies, appropriate technologies and adequate resources to achieve that goal. If our community goal is to keep green spaces open and provide access to fresh, locally-

sourced affordable food; if our desire is to develop greater indigenous energy resources; then we need to pay attention to how we develop our infrastructures, how we allocate, yet protect our water resources, how we educate our next generation, and how we protect and employ our important agricultural lands. As a commissioner on the Board of Agriculture since 2012, I believe I have contributed to moving toward achieving the State's policy goals.

My educational background is in finance and accounting and this has extended into my work experience. Further, I have extensive operational experience in transportation logistics and policies, strategic planning, resource allocation, regulation, and employment initiatives, among others. These experiences have broadened my ability to ask pertinent questions, identify potential options, and guide organizations toward desired outcomes. I have participated on a number of boards and task forces in leadership and committee member roles. I have worked directly with State agencies, farm bureaus, and agricultural associations on issues of transportation and food security. These efforts have all been collaborative in nature.

While I do not anticipate any conflicts of interest, should any arise, I would necessarily take any appropriate action, including recusal in that matter.
