The Department of Land and Natural Resources (Department) supports Governor's Message 813, nominating Ms. Hinaleimoana Wong-Kalu to the Island Burial Council, Island of Oʻahu expiring June 30, 2020.

The Island Burial Councils are established under Section 6E-43.5, Hawai'i Revised Statutes. The Councils determine whether to preserve or relocate previously identified native Hawaiian burial sites, recognize lineal and cultural descendants, and provide counsel and advice to the Department.

Ms. Wong-Kalu was born and raised in the Kona region of Oʻahu. She has a Bachelor's Degree in both Hawaiian Studies and Education. Her past employment includes Kula Aupuni Niʻihau A Kahelelani Aloha School, Kuaokala School, Ke Ola Mamo Native Hawaiian Health Care System, Leeward Community College, Queen Lili'uokalani Children's Center and the University of Hawai'i. She formerly served as past Chair of the Oʻahu Island Burial Council, where she earned the respect of her fellow members as well as that of the general Hawai'i community. She is a well-respected kumu hula and speaks Hawaiian, Tahitian, Tongan and Samoan fluently.

Senate confirmation will ensure that Ms. Kalu-Wong's knowledge and perspective informs the deliberations of the O'ahu Island Burial Council until June 30, 2020.
