In consideration of GOVERNOR'S MESSAGE 821 SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE GAME MANAGEMENT ADVISORY COMMISSION, GUBERNATORIAL NOMINEE, LORI BUCHANAN, FOR A TERM TO EXPIRE 06-30-2019

#### The Department of Land and Natural Resources (Department) strongly supports Governor's Message 821, nominating Ms. Lori Buchanan to the Game Management Advisory Commission for a term to expire June 30, 2019.

Pursuant to Section 183D-4.5, Hawai'i Revised Statutes (HRS), the Game Management Advisory Commission (Commission) shall: 1) serve in an advisory capacity to the Board of Land and Natural Resources (Board); and 2) consist of nine members to be appointed by the Governor in the manner provided in Section 26-34, HRS. The Commission shall include a member from the County of Kaua'i, three members from the County of Maui (one member from each of the islands of Maui, Moloka'i and Lana'i), two members from the County of Hawai'i (one member from East Hawai'i and one member from West Hawai'i), one member from the City and County of Honolulu, one at-large member, and the Chairperson of the Board or the Chairperson's designated representative. Each member, other than the Chairperson of the Board, is required to be a hunter licensed in the State and have leadership experience in working directly with local hunter or shooting organizations. At least one member shall have knowledge, experience and expertise in the area of native Hawaiian cultural practices, and no more than three members shall represent, be employed by, or be under contract to any sector of government.

Ms. Buchanan has been nominated as a member for the Commission from the County of Maui, Island of Moloka'i. Ms. Buchanan is a licensed hunter who has been identified as an advocate for

the hunting community on Moloka'i, many of whom are native Hawaiian homesteaders and hunt for subsistence.

As Coordinator of the Moloka'i/Maui Invasive Species Committee, Ms. Buchanan has nurtured a longstanding and positive working relationship with the Department. She also has an admirable history of public service to both state and county government. Assuming Ms. Buchanan receives Senate confirmation to serve on the Commission, she will step down from her current appointment to the Marine and Coastal Zone Advisory Council with the State Office of Planning. Previously, she served as the Vice Chair of the Legacy Lands Conservation Commission and as the Chairperson of the Moloka'i Planning Commission.

Ms. Buchanan is also well known and respected on Moloka'i as an active member of the 'Aha Kiole Advisory Committee. In this role, she brings great knowledge, experience and expertise in the area of native Hawaiian cultural practices.

Ms. Buchanan's extensive knowledge and experience with hunting issues on Moloka'i and understanding of Hawaiian cultural practices will make her an excellent member of the Game Management Advisory Commission.
