With respect to the bill itself, I feel it repetitive and attempted to pass several times over the years with slight to little modification. It was flawed then and it's flawed now. The state has been closely studying the fishery throughout the state, in particular west Hawaii. What has been determined is that the fishery is very well managed and is sustainable even though I feel that word is arbitrary. If you define sustainable as a fishery that replenishes the biomass that is removed in such a way that no long term damage is done then our fishery is beyond that. The amount of fish removed every year is a small fraction of what comes and goes through natural processes. Furthermore, the areas where the fishery operates actually have higher populations of smaller fish compared to areas where collecting does not occur because no collect zones have ageing populations of large fish. The reason being is that a coral reef can sustain populations that are either or. Either you have small population of large fish or dense populations of small fish in staggering differentials. So the areas we collect in favor small fish with constant larval recruitment and it is absolutely sustainable. The interesting thing is that even in the open areas we have large fish as well but are actually more viable breeders than closed areas because they have less competition so they feed better and are younger which therefore means they produce superior egg quality. A good analogy would be to think about the ideal age for humans to reproduce. A young person is much more capable than a old person. The fishery is in good hands and this question of sustainability has been asked and answered many times over Please take the time to become informed and the answers you are looking for will be self evident. An example is line 2 from page 1 which claims "Populations of nearshore species have disappeared over the last fifty years". I have been diving on Oahu for fifty years. There is no nearshore population of aquarium fish that has disappeared. The reproductive rate of the species I catch is so high, they replenish on a yearly basis. In Hawaii, the small juvenile fish usually appear in late spring to early summer. These juveniles proceed to grow during the summer months, and are catchable by the fall and winter. The cycle repeats itself each and every year. The amount of aquarium fish from previous growth seasons also overlap, which in effect insures fish year round.

Write a reef education bill without an anti aquarium agenda and I will support it. Until then, I cannot support bill HB1457 or any like it.

I went to Tahiti last year and snorkeled with their abundant reef fish and snorkel almost daily here in Waimanalo. If we want tourists to come there has to be something to see. Our reef fish are a treasure to be protected and not exploited for personal profit.

Fragile tropical fish, who were born to dwell in the majestic seas and forage among brilliantly colored coral reefs, suffer miserably when they are forced to spend their lives in glass tanks. Robbed of their natural habitats and denied the ability to travel freely, they must swim around endlessly in the same few cubic inches of water.

The popularity of keeping tropical fish has created a virtually unregulated industry that catches and breeds as many fish as possible with little regard for the animals themselves. While many species of coral are protected under the Convention on International Trade in Endangered Species of Wild Fauna and Flora, most of the fish who end up in aquariums are not.

- (1)An estimated 95 percent of saltwater fish sold in pet shops come from the wild, mostly from the waters around Indonesia, the Philippines, Fiji, and Hawaii.
- (2) More than 20 million fish, 12 million corals, and 10 million other types of marine life—such as anemones, shrimp, and mollusks—are captured every year to support a \$300 million worldwide "hobby."
- (3) Some species, such as the Banggai cardinalfish, have become endangered because of overfishing, a practice commonly employed to satisfy the aquarium industry.
- (4) Collectors douse the coral reefs with cyanide, which is ingested by the fish who live there, and as reported in Scientific American, "[t]he resulting asphyxiation stuns some fish and sends others into spasms, making them easy to grab by hand or net."
- (5) Half the affected fish die on the reef, and 40 percent of those who survive the initial poisoning die before they reach an aquarium.
- (6) Cyanide also kills the coral reefs themselves, and marine biologists rank it as one of the biggest dangers in Southeast Asian waters.

Here I witness collectors permitted to launch vessels, carry collecting equipment and their catch in a closed to collecting FRA area.

I have personally observed a collector actively collecting inside the FRA area, I contacted Kona DOCARE and an officer was not able to respond until 2 hours after the collector had left the area and trailered away.

I observed a collecter actively collecting while using an unmarked AQ boat, I called DOCARE and an officer arrived but was unable to stay until the vessel returned to the boat ramp as he was needed to respond to another incident, no other staff was available.

I have in all reported and submitted evidence to Docare that was passed on to the prosecutors office four times in 3 years and never have I been interviewed, case numbers have gone away.

Collectors are permitted to aggressively contact corals while herding juvenile fish from their natural predator protection finger corals into the nets. I have observed and documented this as well in these photo links:

I wholeheartedly support HB1457. I am a businessman. I have a BS in Zoology and a MS in Tropical Agriculture. Both my undergraduate and graduate studies involved interactions between species.

I have learned to appreciate the powerful symbioses that evolved with living creatures on Earth. The existence of most plants, animals, and fungi are so intertwined that with the elimination of one seemingly small player, an entire ecosystem can collapse. This was illustrated when the California sea otter was nearly wiped out. The great schools of fish disappeared from the Pacific Ocean off the California coast, followed by the fishermen. Scientists discovered that sea otters ate species of sea urchins that dined on kelp forests that, in turn, provided sanctuary to fish species. And kelp forests take CO2 out of the atmosphere through photosynthesis! I think you can see where I am going with this argument.

Many herbivorous fish species have symbiotic relationships with coral reefs. Just one of many examples is the Yellow Tang that eats algae that would otherwise smother the coral reefs. The unchecked growth of algae can lead to coral bleaching and, potentially, the collapse of the entire ocean ecosystem. The Yellow Tang is apparently the favorite species for the local aquarium collectors. The reduction in their numbers alone could greatly harm Hawaii's ocean ecosystem.

The collection of Hawaii's reef fish must be limited, pending more intensive independent research to determine various species populations and dynamics. HB1457 helps address another part of the puzzle in our quest to determine the importance of all these interactions.
