Lynn DeCoite, Vice Chair and Members House Committee on Agriculture Testimony in support of HB1516 Relating to Animal Forfeiture Hawaii Island Humane Society stands with other Animal Welfare organizations around the State in strong support of the passage of HB 1516, which would allow for a society for the protection of animals to petition for full custody of animals that have been rescued prior to the filing or final disposition of criminal charges against the owner of the animals. The following is a current example of why we are in strong support of this measure. The Hawaiian Humane Society rescued more than 300 dogs from a Waianae property as part of an animal cruelty case. To date it has cost them more than \$460,000 to provide the needed care to the dogs AND they are not yet able to adopt them into a permanent home because the owner of the dogs has not yet be criminally charged. These dogs, which have already suffered greatly deserve to be placed in permanent homes as soon as possible. Passage of HB 1516 will allow for the potential of forfeiture to occur prior to criminal charges being filed so that situations like the one happening right now can be avoided in the future. This measure would allow for the animals to be placed in new homes at the beginning of the case, thereby eliminating exorbitant costs of maintaining the animals in limbo while keeping the integrity of the criminal prosecution intact.
