Reduces the minimum Hawaiian blood quantum requirement of certain successors to lessees of Hawaiian home lands from one-quarter to one thirty-second. Hawaiian is the fastest growing race in Hawaii due to inter-racial marriage, yet many Hawaiians don't meet the current Hawaiian Home Lands (HHL) blood quantum criteria for lessees (50%) or successorship (25%). In these financially trying times how do we keep our people from being displaced or worse yet, houseless? HB 451 HD1 SD1 allows ohana members to continue their residence in the ohana hale. Our Prince Jonah Kuhio Kalaniana'ole fought for the Hawaiian Homes Commission Act so his people could return to and stay on our land. Prince Kuhio did not mean to displace one Hawaiian ohana for another, this Bill fulfills his intent and desire.
