On behalf of Hawaii Farmers & Ranchers United we collectively represent 97% of all agricultural revenue on Hawaii Island; \$194 Million out of a total of \$202 total agricultural revenue, and almost 3,000 farmers and ranchers working on 630,000 acres of land.

The Hawaii Aquaculture and Aquaponics Association (HAAA) strongly supports HB 453 HD1, "Relating to Agriculture." Aquaponics is considered to be one of the most sustainable agricultural systems, and is ideal for food production in Hawaii because of its economical use of land area, water, and nutrients. At HAAA's annual conference that was held February 24 at Kapiolani Community College, we were informed that the FDA would likely consider each module of an aquaponic system to be a separate water system that would require extensive annual water sampling in order to comply with FSMA. This sampling requirement will create a significant financial burden on commercial aquaponic producers. The grants proposed by HB 453 HD1 could help offset this burden. We therefore respectfully urge you to pass HB 453 HD1.
