TESTIMONY ON HOUSE BILL NO. 563, RELATING TO DENTAL HYGIENISTS.

TO THE HONORABLE DELLA AU BELATTI, CHAIR, TO THE HONORABLE TAKASHI OHNO, CHAIR, AND MEMBERS OF THE COMMITTEES:

My name is Paul Guevara, D.M.D., M.D.S., Chairperson of the Board of Dental

Examiners ("Board"). I appreciate the opportunity to testify on House Bill No. 563,

Relating to Dental Hygienists which permits licensed dental hygienists in the State to

operate under general, rather than direct, supervision of a licensed dentist.

The Board has not had an opportunity to review this bill. The next meeting of the Board is Monday, February 13, 2017 (the morning immediately preceding this hearing), at which time the Board will discuss and determine its position on this measure. I will be available to relay the information to the committees at this hearing and to answer any questions that the committees may have.

In a previous discussion regarding supervision by a licensed dentist, the Board felt that general supervision may place the dental hygienist in immediate charge of the office while the supervising dentist is not available. From a safety standpoint, there might not be a "responsible person" responding to an emergency situation in the office, Testimony on House Bill No. 563 Tuesday, February 14, 2017 Page 2

whether related to a dental procedure or not. It is the dentists' responsibility to supervise the office team and be present and responsive to the patients, whether an emergency situation or a complication following the administration of a local anesthetic arises.

Dear Respected Members of the Committees on Health and Intrastate Commerce:

The Hawaii Dental Hygienists' Association (HDHA) applauds your efforts to help solve the problem of inadequate oral health care for Hawaii's people. We, as I'm sure many of you on your respective committees are aware, have an on-going oral health access to care issue in the state of Hawaii. The problem is multi-factorial, but varying, restrictive levels of supervision for licensed dental hygienists plays a critical part in limiting access to those who need oral health care.

According to the HAR 16-79-2

"Supervision" means prescribing objectives and procedures and assigning work, provided that the person supervising shall be a licensed dentist. The levels of supervision are defined as follows:

(1) "Direct supervision" means that the supervising licensed dentist examines and diagnoses the condition to be treated, authorizes each procedure, remains in the dentist's office or in any facility defined in section 447-3, HRS, while the procedures are being performed, and shall be responsible for all delegated acts and procedures performed by dental assistants and licensed dental hygienists.

(2) "General supervision" means that the supervising licensed dentist has examined and diagnosed the condition to be treated, and has authorized each procedure to be carried out in accordance with the dentist's diagnosis and treatment plan. The presence of the supervising dentist is not required; provided the dentist shall be available for consultation and shall be responsible for all delegated acts and procedures performed by licensed dental hygienists. In the case of programs under the supervision and control by the department of health or in any facility specified in section 447-3, HRS, the foregoing shall not apply except that the supervising licensed dentist shall be available for consultation, shall be responsible for all delegated acts and procedures performed by licensed to section 447-3, HRS, the foregoing shall not apply except that the supervising licensed dentist shall be available for consultation, shall be responsible for all delegated acts and procedures performed by licensed by licensed dental hygienists and the procedures pursuant to section 447-3, HRS, shall have been prescribed by a licensed dentist or otherwise be authorized by law.



Under HAR 16-79-2 for Hawaii dental hygienists practicing under DIRECT supervision in private practice, a patient must be examined by a licensed dentist prior to treatment, treatment must be assigned to a licensed dental hygienist, a post-op review of the treatment must be completed by the dentist and then, the dentist can assign further treatment as needed. The dentist must also be physically present the entire time, never stepping out of the office. This practice is time consuming for the dentist and restrictive on they hygienist. What are other states across the nation doing?

Forty-five of the 50 states authorize dental hygienists to work under some degree of general supervision, meaning that a dentist has authorized a dental hygienist to perform procedures, but need not be present in the treatment facility during the performance of those procedures. Hawaii currently permits general supervision of dental hygiene services in "non-traditional" public health dental settings, such as clinics, nursing homes, hospitals, and facilities that treat people with developmental disabilities.

Beginning in 1915, dental hygienists licensed in Connecticut were permitted to practice in private dental offices, or any public or private institution under the general supervision of a dentist. One hundred years later, almost every state in the nation permits general supervision levels for dental hygienists, with most states sanctioning various levels of expanded function practice acts, such as the administration of local anesthesia and nitrous oxide analgesia. Many states also allow dental hygienists to provide restorative functions, such as applying cavity liners and bases, and placing, carving, and finishing amalgam and composite restorations.

Alabama, Mississippi, North Carolina, Hawaii, and Georgia are the only states in the nation where legislation to allow general supervision in private practice has not been passed. The rationale most of these states provide for restricting dental hygienists from practicing without the direct supervision of a dentist focuses on concerns about quality and safety, even though no clear evidence exists to support such restrictions. Furthermore, if the basis for restricting scope of practice is a concern about safety and efficacy, these concerns should apply regardless of the income level of the recipient, or the site of care.

This rationale makes one wonder what justification could be provided to explain why dental hygiene services provided in public health settings for impoverished and incarcerated residents of Hawaii is considered "safe," but the same dental hygiene services provided without the direct supervision of a dentist in private practice is considered a "public safety" issue, especially considering that 45 of 50 states P.O. successfully and safely allow this level of supervision for dental hygienists without safety concerns.

The 2014 National Governors' Association report suggests that states should consider doing more to allow dental hygienists to fulfill dental needs for the underserved by freeing them to practice "to the full extent of their education and training." Throughout the nation, policymakers, consumer advocates, and oral health coalitions have started innovative programs to extend the reach of oral health-care delivery to the underserved by altering supervision and/or reimbursement rules for dental hygienists, and exploring new professional certifications for advanced-practice dental hygienists.

Considering all of the accomplishments and advances made in dentistry during the last century, it's difficult to understand why there are still a handful of states that honor antiquated practice acts. HDHA feels these types restrictive policies are harmful to the public's oral health not dental hygienists practicing under general supervision.

As the largest association representing Hawaii's licensed dental hygienists', HDHA strongly **supports** the intent of **HB563** to address the prevention of dental disease among Hawaii's people. Dental hygienists possess the education and training to fulfill the goals described in this bill and we look forward to working toward our common goal of increased oral health care and decreased dental disease in our great State.

Honorable Committee Members,

I am writing in support of HB 563

My name is Sierra Spruce and I have been a full time practicing dental hygienist for 46 years, 31 of those years in Kona, Hawaii. I have served in leadership positions in both Texas and Hawaii. I served on the very first Dental Hygiene Advisory Committee to the Texas State Board of Dental Examiners, and have served as a grader for the Hawaii dental hygiene board exams.

For all the years I worked in Texas, we had general supervision for dental hygienists without any problems or incidents. After I moved to Hawaii, I was informed that the Texas Board had changed the ruling to direct supervision but it was so unpopular that after a year or so, it was changed back to general supervision.

Dental Hygienists are professionals who have been well educated, tested and licensed and who receive mandated continuing education yearly. We are capable of providing dental hygiene services in our offices and in public health settings with a mandate from a dentist without the dentist being physically present. This type of supervision has worked well in most states in the US. Hawaii is one of eight states who still require direct supervison of hygienists.

In the past, when my employer has been ill, we have had to close down the office, cancelling my patients as well as his. This has proved to be a hardship for our practice. Offices in Kona are extremely busy and have many patients scheduled out for future months. Under the general supervision model, I could see the hygiene patients in his absence and stay current with our heavy patient load.

This change is long overdue.

It has been my observation, that when a dentist has the misfortune of becoming seriously ill or injured, or simply has the flu, everything comes to a stop at the dental office. Because the dental hygienists work under direct supervision of the dentists, they cannot even see the patients of record for maintenance. Many of these patients are put at risk because of systemic complications. If they try to go to another office, they find many other offices are booked well in advance and they cannot be seen. Their conditions break down. The dental hygienists and teams are out of work until the doctor returns, creating financial hardship for them, as well as the dentist. If the hygienists could work under general supervision, the dentists could still have some income during personal crisis, the hygienists and office staff could continue working, and patients of record could access continued care. Dental hygienists have been practicing under general supervision in public health settings without incident for many years in Hawaii. THIS IS IN REGARDS TO HB 563.

I am writing in opposition to the bill allowing licensed dental hygienist to practice under general supervision of a dentist rather than direct supervision.

As it stands right now the dental hygienist are not required to have liability insurance themselves because they are utilizing the liability insurance of the dentist to practice. Therefore if they would like to practice under general supervision then they should be required to get their own liability insurance.

Another point is the one regarding taking x-rays. Ethically, the dental hygienist cannot take x-rays on their own unless a dentist is present to do an examination first, according to the guidelines of the American Dental Association. According to the guidelines of the ADA, the Dentist needs to examine the patient first, then order the necessary x-rays. How will the hygienists do this if there is only general and not direct supervision.

A final point in opposition to this bill is the one regarding local anesthesia. Dental hygienists that are certified to give local anesthesia would have a problem under general supervision should a crisis arise when they are administering local anesthesia to a patient and not be able to handle the problem because they are not highly trained like a Dentist to take care of the problem

Comments: Having practiced dentistry in two other states that did not require direct supervision (IL and CA), I can say that allowing dental hygienists to practice under general supervision can only promote better dental health statewide. Also, in Hawaii, if I as the dentist have to leave the office for any reason, then none of my employees can be wroking which puts an undue strain on any dentist to always be in the office so everyone can get their hours in. It is time for Hawaii to relax this regulation as it does not make any sense to keep it in force.
