H.B. 727, H.D.1 RELATING TO MOTORCYCLES

House Committee on Judiciary

The Department of Transportation **opposes** H.B. 727, H.D.1 that allows motorcycle and motor scooter lane filtering.

This bill permits motorcycles and motor scooters to proceed between stopped lanes of traffic (lane filter) in the same direction at a reduced rate of speed that does not exceed ten miles per hour.

The bill indicates that "lane filtering" would increase safety. However, in Hawaii, during calendar years 2009 through 2015, only two (2) out of 162 motorcycle and motor scooter fatalities involved rear end collisions. The description of the two fatal crashes are as follows: (1) a motorcycle operator struck another motorcycle operator from behind and (2) a motorcycle operator struck the driver of the motor vehicle from behind. Therefore, the data suggests that "lane filtering" will not address the current issues of motorcycle and scooter fatalities. Furthermore, "lane filtering" would increase the number of conflict points between motor vehicle drivers and motorcycle/motor scooter operators.

Also, with the recent trend of narrowing lanes on State and County roads to accommodate the current traffic volumes, the motorcycle rider and other vehicle operators have less room to maneuver. Allowing "lane filtering" on all roads statewide may cause an increase in collisions. If collisions were to occur that resulted in injuries as a result of "lane filtering" during "peak-hour" traffic, it would further exacerbate traffic congestion.

Report Title: Transportation; Motorcycle Lane Filtering

Description:

Prohibits motor vehicle operators and occupants from interfering or obstructing motorcycle and motor scooter operators and passengers from lawfully travelling between lanes of same-bound traffic that is stopped at a marked or unmarked intersection or due to congestion, when it is safe to do so, on main streets, roads, highways, and freeways.

SBU Recommends Its Members Support Bill SB No. 727

For the reason expressly described in the preamble to Bill H.B. No. 727 (the "Bill") SBU recommends its membership support the Bill and in particular, Lane Filtering as described in the Bill effectively achieves the following benefits at no expense or "external cost" to the Hawai'i motoring public at large:

(1) It reduces the risk of loss of injury and loss of life sustained by Motorcycle operators and passengers (Motorcycle is intended here to include Motor Scooter) caused by rear end accidents from automobiles and other motor vehicles generally. The Motorcycle Safety Foundation of in a report of the US Government Department of Transportation, National Highway Traffic Safety Administration stated:

"A motorcycle's narrow width can allow it to pass between lanes of stopped or slow-moving cars on roadways where the lanes are wide enough to offer an adequate gap. This option can provide an escape route for motorcyclists who would otherwise be trapped or struck from behind. There is evidence (*Hurt*, 1981) that traveling between lanes of stopped or slow-moving cars (i.e., **lane splitting**) on multiple-lane roads (such as interstate highways) slightly reduces crash frequency compared with staying within the lane and moving with other traffic." ¹

Under the National Highway Traffic Safety Administration's ("NHTSA") National Center for Statistics and Analysis, 2005 Report studying causes of "Fatal Two-vehicle Motorcycle Crashes" of the 1,792 Motorcycle and passenger vehicle collisions reported 204 (11%) involved rear-end collisions involving Motorcycles either rear-ending the automobile 139 times (68%) or the automobile rear-ended the Motorcycle 59 time (29%).²

- (2) Motorcycle lane filtering will allow Motorcycles to move through stalled and stopped traffic, especially during gridlock on Oahu's freeways, thereby eliminating overheating problems associated with air-cooled Motorcycles, which, unlike motor vehicles, have no radiators and, therefore, rely on movement to maintain cooling. On freeways, stalled and overheated Motorcycles constitute an additional safety risk to their operators, passengers, and other motorists and safety vehicles. Motorcycle lane filtering eliminates the cause of overheating by allowing motorcycles and motor scooters to move through stopped and gridlocked traffic, thereby eliminating the risk of serious personal injury and property damage.
- (3) Third, motorcycle lane filtering allows motorcycles and motor scooters to move through stopped traffic, which allows some modest alleviation of the traffic congestion and is a positive sum gain in relief from the immediate traffic congestion for all other motorists as well.

Points of Support:

SBU takes the position that the proposed Bill H.B. No. 737 should be strongly supported by its members as a safety measure for Motorcyclists in the form submitted, on the grounds described and for the reasons outlined above and in particular it accomplishes three clear benefits at no costs, traffic delays, or increased risk of safety or inconvenience to other motorist, in particular:

- 1. Reduced risk of injury or death to Motorcyclists by an approximately 11% reduction in rear-end accidents involving Motorcycles;
- 2. Reduced incidents of stalled and over-heated Motorcycles and thereby reducing the associated costs, inconvenience and risks of injury sustained by Motorists stranded on the highways and freeways by an overheated Motorcycle.
- 3. Alleviation of traffic congestion as Motorcycles filter through traffic.

Dear Chair Nishimoto, Vice Chair San Buenaventura and Members of the Committee:

AAA Hawaii was founded in 1915 in Honolulu and is a leader in motorist services and a strong advocate for traffic safety. With more than 157,000 members, service to and the safety of our members, other motorists, and all road users is our founding and continuing purpose.

We have serious traffic safety concerns with the proposal to allow motorcycle lane splitting, sometimes referred to as filtering, in Hawaii, and OPPOSE the proposed legislation.

Hawaii is among the 49 states that prohibit lane-splitting. California is the only state that does not explicitly prohibit lane-splitting. Even in California, where such practice is authorized, in a poll of California drivers in 2012, most drivers disapproved of lane-splitting. They felt it was unsafe and that it might cause a crash. The U.S.D.O.T., National Highway Safety Administration (NHTSA), and the Motorcycle Safety Foundation are calling for more research to provide information about the safety or dangers of lane splitting.

Considering an almost unanimous national restriction on lane splitting, and the call by credible national traffic safety authorities for additional research on this issue, we believe that allowing lane splitting in Hawaii is ill advised and will put traffic safety at risk.

Comments: In steadfast support of the measure as it would help alleviate traffic congestion for Hawaii's motorcycle community. Motorcyclists are the one of the safest motoring groups on today's highways and would understand the kuleana given if this measure passes. Traveling to and from 'Ewa Beach on the H-1 freeway, I have used the HOV and Zipper Lane for the morning commute and it works fine. However, it becomes more difficult during the afternoon H-1 WB commute as there is no afternoon Zipper Lane available and the HOV lane becomes a nightmare to travel on. I have seen for myself many motorists vent out their frustration on motorcyclists because they try to keep the minimum SAFE distance between cars and solo motorists prohibitively diving into the HOV lane without looking first for a motorcyclist already in the lane. With no disrespect to HPD's Solo Bike/Traffic Units, the lane is rarely enforced to deter such behavior and has often led to traffic incidents. Further, adding to the frustration of the weekday commute home. Besides the HOV lane, the second left lane, has been broadened, and can accommodate a full-size car/truck abreast with a motorcycle. The lane starts from the airport (near the Zip Mobile shack) and ends near the H-2 Interchange. The shoulder lane can also accommodate motorcyclists, as seen by HPD Solo Bike officers, who use the lane to traverse slowly thru traffic during rush-hour. Thus, lane filtering would give more lane availability for vehicles as each motorcyclist moves out of the way to travel further on and helping traffic congestion. Subject HB 727 SUPPORT

Esteemed legislators,

I am a retired Maui Police Department Lieutenant who spent 25% of my career in the Traffic Section. I am in support of the measure regarding motorcycle lane filtering. Here are my reasons:

Active police officers are told what they can and cannot say to the legislature but we who have retired can speak freely. The question to ask anyone who testifies on this measure should be DO YOU RIDE A MOTORCYCLE? If the answer is no, then they probably do not know.

Those in opposition of this legislation are only speculating that there will be more collisions if this bill passes. The research actually shows that in slowed or stopped traffic, motorcycles are susceptible to more rear end collisions, frequent breakdowns due to overheated motors, and other related incidents due to the operator having to constantly balance and put his or her feet down, and overuse of the clutch.

I am an experienced and safe motorcycle rider. I have had the opportunity to travel to the mainland and ride. I experienced extremely heavy traffic in Oakland and San Francisco California, and without any specialized training, I was able to execute lane filtering with ease, even on the largest production motorcycle that is made in America.

The Hawaii motorcycle operator skills test, which is required for licensing actually assesses all the skills needed to properly execute lane filtering. These include slow riding and balance, safe lane changes and staying within designated lanes. The lanes used in the oval and figure eight on the test are much narrower than what would be offered by slowed or stopped traffic. I would recommend that the bill include language that only licensed motorcycle operators be authorized to do lane filtering.

The notion of also including shoulder lanes during peak traffic hours for motorcycles is a good idea. Currently Honolulu Police solo bike officers already do lane filtering and shoulder riding when having to move through stalled traffic more quickly. I have never heard of any of them being seriously injured or killed by performing these maneuvers. And they do it at higher speeds than would the law abiding citizen motorcycle rider.

Finally, I agree with the people who testify in favor that the actual decision on whether or not to split or filter lanes by a motorcyclist rests with the operator. If the actual space is too small to traverse safely, or if the operator lacks the confidence to execute the maneuver, he or she should use discretion and not do anything that would be unsafe or uncomfortable. Operators with only a permit should not attempt the maneuver until proficiency is demonstrated through passing the skills road test.
