Purpose of Bill: Appropriate funds for the executive office on early learning to enter into contracts with third party providers for family child interaction learning programs.

EXECUTIVE OFFICE ON EARLY LEARNING'S POSITION: The Executive Office on Early Learning (EOEL) **supports** HB 937, HD 1 with recommendations for amendments.

Family is the single most important influence in a child's life. Parents and families have the most direct and lasting impact on children's learning and development of social competence. Children thrive when parents actively promote their positive growth and development. Families are a child's first and lifelong partner in education and early childhood providers need to build the kind of relationships that engage families as active partners early in their child's education.

EOEL respectfully requests that the language in HB 937, HD 1, Section 1, lines 1-7, be revised to: "The purpose of this Act is to appropriate funds for the Executive Office on Early Learning to enter into contracts with third party providers for the implementation of services which offer opportunities for family and community engagement as well as parent education and support." Section 2, lines 12 – 17 should also be replaced with the following, "...the Executive Office on Early Learning to enter into contracts with third party providers to develop and implement programs that support families to take an active role in the social, emotional, and cognitive development of their young children."

Research demonstrates that early education is a key factor in lifelong success for all children, and we strongly urge the legislature to promote, enhance and support the efforts of the State of Hawai'i to appropriately address the needs of Hawai'i's pre-kindergarten children, including supporting family-child interaction learning programs as part of a mixed-delivery early learning system. By allowing the Executive Office on Early Learning to enter into contracts with third party providers for family-child interaction learning programs, this measure will help to ensure school readiness for Hawai'i's children prior to entering kindergarten, especially Native Hawaiians.

The Chamber of Commerce Hawaii ("The Chamber") **supports** HB 937 HD1, which makes an appropriation for the Executive Office on Early Learning to enter into contracts with third party providers for family-child interaction learning organizations.

The Chamber is Hawaii's leading statewide business advocacy organization, representing about 1,600+ businesses. Approximately 80% of our members are small businesses with less than 20 employees. As the "Voice of Business" in Hawaii, the organization works on behalf of members and the entire business community to improve the state's economic climate and to foster positive action on issues of common concern.

The Chamber strongly believes that focusing on early childhood is critical because brain development takes place by age five. My name is Billy Richards and am currently serving as the Project & Advocacy Manager for Administration for Partners In Development Foundation (PIDF). However, I am submitting this testimony in strong support of the intent of this Bill, as an individual and private citizen.

FCIL (Family Child Interaction Learning) programs provide tremendous support in settings that are a very affordable option for most families, especially those who cannot bear the expense of a drop-off preschool, or who don't qualify for financial assistance.

These kinds of programs also allow families to go to preschool with their child and learn along with them, thus not only preparing our children to make the transition into the formal learning process, but also giving the caregiver the means and incentive to support that child through the coming years.

Family child interaction learning programs works closely with parents to teach them how to be their child's first and foremost educator. It is a mixed delivery system that also equips parents to be well informed and how to be an advocate for their child for the long term.

Teachers can only do so much. We need parents to continue at home what teachers provide for the student while in the classroom, thus supporting their effort.

Funding for these programs will provide a needed service to many of our keiki who today must enter a system without proper preparation.

TITLE OF BILL: HB 937, HD 1 RELATING TO EARLY LEARNING

Honorable Chair, Michelle Kidani, Vice Chair Kaiali'i Kahele and Committee Members

I **strongly support** of **HB 937, HD 1** which allows an appropriation for the Executive Office on Early Learning to enter into contracts with third party providers for family-child interaction learning programs.

HB 937, HD 1 enables the Executive Office of Early Learning (EOEL) to contract with third party providers that are involved in work empowering families so that they have the knowledge and skills to actively support the healthy social, emotional, and cognitive development of infants, toddlers, and preschool aged children who may not otherwise receive early learning services. They are important programs that are part of a mixed-delivery early learning system. The FCILs and other variations on family engagement models are recognized in statute as one of the 4 types of early learning programs that make up our current birth - PK early education system and serve 3,400 children statewide with over 50% of these children under the age of 3-years-old. 31% of these children live at or below the federal poverty level and many are from vulnerable populations such as immigrant or homeless families.

Many of the early learning programs that are based on a family empowerment models originate from the Native Hawaiian community because the other options available were inaccessible or were structured in ways that were in contrast to the values and needs of Native Hawaiian 'Ohana. In areas with high populations of Native Hawaiians, FCIL and other innovative programs were created by leaders within these communities that were sensitive to the cultural values and concerns of Native Hawaiians and Pacific Islander families. I would suggest that a broader definition that encompasses the variety of programs built on family and community engagement or parent education and support models is adopted in the legislation.

They are a vital link in our system of early learning services. These programs reach out to families at homeless shelters, in the prisons, on the beaches, or in public schools in communities in ways that enable them to reach families who are the most likely not to be able or willing to make use of more conventional preschools. Some of the organizations that created these programs designed programs based on what they knew about families in Native Hawaiian communities rather than asking families to make choices that are difficult such as putting the care and learning of a preschool aged child over a younger sibling who may be a toddler. They have particularly powerful family engagement practices that accomplish much more than support a child's development and learning.

They engage in powerful, intergenerational community development work. Furthermore, because these types of programs have benefited from the generous federal dollars Senator Inouye has championed for programs that serve Native Hawaiians, they have a history of collecting data to evaluate outcomes based on assessments that are well recognized in the field such as the ASQ, ASQ-SE, and PPVT and to seek other quality measures such as program accreditation by the National Association for the Education of Young Children or the World Indigenous Nations Higher Education Consortium Accreditation. Moreover, these programs contribute to workforce development in a way that supports the economic independence of parents by making recruiting from within the communities they serve and enabling those working with our youngest keiki to attend college and obtain a degree or to better themselves through job embedded professional development. The workplace practices of family these programs are supportive of the values and competing familial demands placed particularly on young mothers who are Native Hawaiians or Pacific Islanders.

The family-child interaction programs go where other types of programs are not structured to go, provide access to families other programs are not structured to serve, and encourage the voice and conviction of the parents and families within our most vulnerable communities. If we are going to turn around the career and college readiness of our most vulnerable keiki and empower their parents to become financially self-sustaining, these programs must be included as part of our solution. We have much to learn from them. Including FCILS in legislation is critical as we strive to build an early learning system that builds on the collective strengths and assets of our community based and public institutions. By doing so we will be able to make sure that the early childhood practitioners that serve in these programs obtain vital resources and also that the rest of the early learning system, including our public school settings, are able to learn from their successes.
