Chair Lee, Vice Chair Lowen, and Members of the House Committee on Energy and Environmental Protection,

The Office of Environmental Quality Control (OEQC) administers Hawai'i Revised Statutes (HRS) Chapter 343, Environmental Impact Statements (EIS). The purpose of the EIS law is to "establish a system of environmental review which ensures that environmental concerns are given appropriate consideration in decision making along with economic and technical considerations" (HRS §343-1). Additionally, the OEQC serves "the Governor in an advisory capacity on all matters relating to environmental quality control," as directed in HRS §341-3.

The OEQC supports the intent of these resolutions. Given the scope of the proposal, other efforts to combat climate change underway in Hawai'i, and the evolving nature of the federal government at this time, leading this proposed effort in collaboration with the Department of the Attorney General and the Legislative Reference Bureau would require a high degree of coordination and research that would strain our current resources. We have a request into the Legislature for increased funding and an office assistant position to enable the OEQC to better fulfill its current obligations and undertake requests such as this. Should the Legislature make the appropriate, the OEQC would be better situated to undertake this request. Therefore, the OEQC requests that the Legislature revisit this proposal in the future.

Chair Lee and Members of the Committee:

Good morning Chair Lee and members of the Committee, my name is Charlotte Carter-Yamauchi and I am the Director of the Legislative Reference Bureau. Thank you for providing the opportunity to submit written comments on H.C.R. No. 203/H.R. No. 131, Urging the Office of Environmental Quality Control, in Cooperation with the Department of the Attorney General and the Legislative Reference Bureau, to Prepare Environmental and Legal opinions of Future State Regulations and Legislation that might be Deemed Necessary to Combat Climate Change and Prevent the Regression of Environmental Protection.

The purpose of these measures is to urge the Office of Environmental Quality Control:

(1) In coordination with the Department of the Attorney General, to prepare environmental and legal opinions of future state regulations that might be deemed necessary to combat climate change and prevent the regression of environmental protection;

- (2) In coordination with the Legislative Reference Bureau, to complete a study of the potential legislation needed to maintain climate change environmental protection; and
- (3) In coordination with the Department of the Attorney General and the Legislative Reference Bureau, submit a report of its findings, analyses, and recommendations, including any proposed legislation, to the Legislature no later than twenty days prior to the convening of the Regular Session of 2018.

The Bureau takes no position on this measure, but submits the following comments for your consideration regarding the request that the Office of Environmental Quality Control (OEQC) and the Bureau study "potential legislation needed to maintain climate change environmental protection."

As drafted, the scope of the study requested of the OEQC and the Bureau seems overly broad and does not provide sufficient guidance on what constitutes "maintain[ing] climate change environmental protection." Furthermore, there is no guarantee that federal legislation or regulations will be enacted or amended within the timeframe that the study is to be performed. Consequently, the OEQC and the Bureau would probably be unable to perform any meaningful analysis, thus rendering any such evaluation a simple exercise in conjecture. Moreover, if federal legislation and/or regulations are drafted in a manner that prohibit states from enacting more stringent environmental standards, then proposing state legislation to maintain higher environmental protection standards would be futile.

It seems that, while the purpose of these measures is commendable, without actual proposed federal legislation or regulations to evaluate, the study requested in these measures may be premature.
