Chair Nishimoto and members of the House Committee on Judiciary, thank you for the opportunity to provide comments on House Concurrent Resolution No. 64. The purpose of this resolution is to urge election officials to provide information factsheets about various questions that appear on the ballot.

The Office of Elections too believes an informed electorate is essential to a healthy democracy. However, if the intent is to produce educational materials to voters, it is not within the scope or mission of the Office of Elections to interpret constitutional amendments proposed by the legislature. We believe that educational materials would be better produced by subject matter experts.

Prior to the amendment of HRS § 11-2 in 2003, the Office of Elections was statutorily responsible for distributing educational materials produced by the Legislative Reference Bureau based on its interpretation of proposed constitutional amendments, including valid arguments for and against ratification.

Chair Nishimoto, Vice-Chair San Buenaventura, and Committee Members:

The League of Women Voters of Hawaii strongly supports HCR 64 that requires the publication of information on the proposed constitutional or proposed charter amendments that appear on an election ballot. Despite efforts by the media and organizations like the League to raise awareness and provide nonpartisan information about ballot questions, many voters are surprised when proposed constitutional amendments or proposed charter amendments appear on their ballot.

We recognize that express legal language may be required for the proposals, but this often means the proposal is difficult to understand. The ballot and charter education should explain what each proposed change means in simple, everyday language. Additionally, "pros and cons" for each change should be presented in a factual, nonpartisan fashion.

For years, the League has advocated voter information, especially on issues, and has provided this information ourselves, when possible. But it would be better if this was a routine aspect of voter service provided to all Hawaii residents by the State Office of Elections and County Clerks in both electronic and paper formats. Previously we have heard there was never "enough money "to do this. But what can be more important than an informed electorate? We strongly support this resolution and urge you to pass the measure.

We respectfully request that the language of the resolution be modified so that it accommodates voting by mail statewide. This is straightforward. References to polling place should also include "or each voter service center." Thank you for the opportunity to submit testimony.
