Title of Bill: SB 1286 RELATING TO PRIVATE TRADE, VOCATIONAL, AND

TECHNICAL SCHOOLS.

Purpose of Bill: Narrows the scope of the private trade, vocational, and technical school

licensure program within the department of education. Establishes a licensing fee to ensure the sustainability of the licensure program. Establishes a license renewal process and fee. Creates the private trade, vocational, and technical school licensure special fund.

Department's Position:

The Department of Education strongly supports SB 1286 relating to private trade, vocational and technical schools.

Licensing Private Trade, Vocational or Technical (PTVT) schools is misaligned with the Department's primary mission. Our primary mission is focused on K-12 education to ensure that all public school students can reach their fullest potential and attain their aspirations in the 21st century.

PTVT administration by the DOE continues to take away valuable resources and time that should be solely focused on providing direct services and supports for Hawaii public schools, educators and students.

However, a special fund to support the PTVT licensing program operations will help address budgetary issues and assist with the licensure program's sustainability.

Further, the Department favors the proposed scope of licensure which requires a school to provide evidence that a license is required for students currently receiving or applying to receive financial aid under Title IV of the Higher Education Act of 1965.

Thank you for this opportunity to provide testimony on SB 1286.

TESTIMONY ON SENATE BILL NO. 1286, RELATING TO PRIVATE TRADE, VOCATIONAL, AND TECHNICAL SCHOOLS

TO THE HONORABLE MICHELLE N. KIDANI, CHAIR, AND TO THE HONORABLE ROSALYN H. BAKER, CHAIR, AND MEMBERS OF THE COMMITTEES:

My name is Catherine Awakuni Colón, Director of the Department of Commerce and Consumer Affairs ("DCCA" or "Department"). DCCA appreciates the opportunity to offer comments on S.B. No. 1286, Relating to Private Trade, Vocational, and Technical Schools.

S.B. No. 1286 revises the current private trade, vocational and technical school law that is administered by the Department of Education ("DOE"), creates a private trade, vocational and technical school licensure special fund, and implements a licensure fee.

The Department's testimony relates solely to section 4 of the bill to the extent DCCA is referenced in that section, and takes no position regarding the remainder of the bill. First, regarding section 4 of the bill, the Department requests that references to DCCA complaints history at renewal found on page 8, lines 19 to 21, be revised to expand this renewal requirement to include complaints filed within the prior two years with any state or federal governmental agency or directly with the school. Capturing complaints filed against the school at any venue will provide DOE with a more complete picture of the school's complaints history for purposes of the renewal process. In the alternative, if DOE does not intend to review complaints information at renewal, the Department suggests that this language be deleted from the bill. The Department offers the following proposed language for the Committee's consideration as a possible replacement to the current language found at page 8, lines 19 to 21:

(2) Submitting a list of complaints officially filed within the past two years with any state or federal government agency or directly with the school; and

Also, regarding section 4 of the bill, subsection (e) on page 9, lines 2 to 7, the Department requests that this subsection be deleted. DCCA has received complaints regarding DOE schools in the past without the need for explicit authorization and is concerned that the language in the bill is both unnecessary and confusing.

Thank you for this opportunity to provide comments on S.B. No 1286. I am available to answer any questions that the Committee may have.

RELATING TO PRIVATE TRADE, VOCATIONAL, AND TECHNICAL SCHOOLS

Senate Bill No. 1286 amends Chapter 302A, HRS, and requires the Department of Education to only license certain private trade, vocational, or technical schools that require legal authorization by the State to be considered eligible institutions for student aid programs under the federal Higher Education Act of 1965, as amended. The purpose of the measure is to narrow the scope of the licensure program and to establish a licensing fee to ensure its sustainability.

The measure also establishes the Private Trade, Vocational, and Technical School Licensure Special Fund. The measure authorizes the deposits of revenues and fees into the special fund established by the bill: initial license fee of \$10,000 and renewal fee of \$10,000 every two years. Moneys in the special fund are to be used to fund activities related to licensure requirements.

The Department of Budget and Finance (B&F) does not take a position on the licensing of certain private trade, vocational, or technical schools. However, as a matter of general policy, B&F does not support the creation of any special fund which does not

meet the requirements of Section 37-52.3 of the HRS. Special funds should: 1) serve a need that cannot be implemented under the general fund appropriation process; 2) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries of the program; 3) provide an appropriate means of financing for the program or activity; and 4) demonstrate the capacity to be financially self-sustaining. In regards to Senate Bill No. 1286, it is uncertain if the special fund will be self-sustaining.

Thank you for your consideration of our comments.

SB 1286 unfairly targets the Massage Therapy profession in the State of Hawaii. Currently 18 out of 34 licensed vocational schools are engaged in the training of Massage Therapy / Shiatsu. Licensed vocational schools would be hard-pressed to survive the financial burden that SB1286 places upon them. The quality of massage therapy training and the massage therapy profession in the State of Hawaii would suffer as a result, restricting options for quality massage therapy training throughout the Islands.

I am writing in opposition to SB 1286 for the following reasons:

The timeline proposed by SB1286 is unrealistic and impossible to meet. For Massage Therapy schools, the only route to accreditation is through COMTA (Commission on Massage Therapy Accreditation). The initial application process for can easily take 1 year or more. SB1286 requires that schools be in compliance with these standards by September 1, 2017, an unrealistic timeframe.

The cost of accreditation would result in higher, less affordable tuition rates for our students. While accreditation is a laudable goal for a school, it is one which incurs significant cost (1) the cost of the initial accreditation process (approximately \$10,000), (2) the annual cost of accreditation (\$1500+ per year), and (3) the financial and administrative burden involved in maintaining accreditation status.

Requiring accreditation as a criterion for vocational license is impossible for Massage Therapy schools! For a school to be eligible to apply for COMTA accreditation, the school or program must be state-approved!

"Prior to accreditation, programs must receive state and/or any other applicable approvals to offer the certificate or degree.

...A. The programs under consideration for COMTA accreditation have current approval(s) as required by law and regulation in their jurisdictions, including state education agencies, state private postsecondary regulators, or massage or esthetics licensing boards."

Accreditation favors large institutions and corporations. Small, independently-owned massage schools generally cannot afford the overhead which comes with accreditation.

Currently there are only 49 accredited massage therapy training programs in the U.S. Almost half of the programs listed are within larger institutions, such as community colleges or technical schools. COMTA acknowledges the burden that accreditation places on smaller schools:

"In the last few years, there have been many national conversations about the need for improved and consistent educational standards in the massage/bodywork field. At the same time, there are many professionals who question mandatory accreditation because of the burden for smaller schools.

"As a solution, the Commission unveiled this innovative status in May 2015 to recognize quality curriculum and instruction without the additional financial and administrative burden of accreditation. This will honor those schools doing exceptional work, incorporating the COMTA Curriculum Competencies and

ELAP Outcomes into their programs, and help move the profession forward in a more inclusive manner."

The proposed licensing fees are exorbitant. The initial license fee of \$10,000, and subsequent renewal fee every two years of \$10,000, is an exorbitant fee. The current fee of \$50 could certainly stand to be increased. However the \$10,000 fee would be burdensome to each individual school.

On the practical level, SB 1286 is ill-conceived and impractical. I strongly oppose it.

Dear Representatives,

My name is Carmel Andrews, and I am writing in representation of the Maui Academy of Healing Arts. We are a vocational school for massage therapy licensure for the State of Hawaii, in operation since 1988. I am writing to declare **opposition** to the current bill set for hearing on Wednesday Feb. 8th, in regards to the DOE's revised proposals for licensure to local trade and vocational schools.

The effect of this proposal would have devastating consequence to our ability to provide this educational alternative to the community. For decades MAHA has operated in compliance with the DOE in order to provide a high standard alternative education to not only the local community, but students from all the across the US and even internationally.

We provide education opportunities to veterans through VA funding, international students, Native Hawaiian students via the Alu Like scholarship, and even most currently through scholarships from the local womens shelter to victims of domestic violence. Although we may continue to provide some of these services, our school also depends on the diversity of students coming from different regions to train and perhaps return to their respective states and be able to transfer their DOE approved education credit to their licensing board so that they may legally practice their trade and retain the value of their education. I believe is also necessary to have this approval to maintain our VA program.

We support the ability for the DOE to administer to us, and are willing to negotiate to have that administration continue, however the proposed bill SB1286 is not only burdensome and untimely, but frankly, borders extortionist in its fee revision and expectation. NO small vocational school will be able to meet and comply with the proposal set forth, much less maintain the exorbitant application and renewal fees. These fees are burdensome in the extreme. The DOE also in asking for these fees, demands that we in tandem maintain OUTSIDE accreditation with a third party agency (in our case this would be COMTA.org) which also carries a massive application fee, and renewal fees. If the DOE is not interested in regulating the curriculum for our vocational programs and demands it be accredited by an alternate agency so that they meet a standard, why are we paying an additional 9,000\$ every two years to the DOE to administer to us? Why not just request accreditation or some alternative requirement? At the very least this needs further testimony and negotiation.

This bill would give our school 7 months to come into compliance with almost 70,000\$ in fees and bonds, and demand that we obtain accreditation from an outside source that can take more than a year to finalize. Concurrently, if a vocational would wish to pursue this process in any time frame outside of their current valid DOE licensure, for instance if more time was needed to manage the large fee submission and create a functioning administration to meet these new requirements....they could expire their current DOE approval, not be able to renew it, and in turn NOT be able to apply for accreditation

by a third party agency because they require valid DOE licensure. As proposed, this would shut down the ability ongoing for ANY school to comply, at least within our field.

This does not even begin to address the personal administrative burden each school would have to take on in order to document and comply with federal agencies regarding student aid, and maintenance of third party accreditation. All of our curriculum would be monitored by an outside agency and we would in essence be paying the DOE an exorbitant rate to do very nearly what it does now. This is unacceptable.

Lastly, if we chose not to meet these outrageous proposals for licensure, we would lose the diversity of our student body, and practitioners gaining Hawaii licensure would lose their ability to maintain a license if they ever needed to work or live on the mainland, or apply for additional certifications.

Massage Therapy is rapidly growing and evolving into a highly respected adjunct healthcare modality. In many states practitioners are now legally accepted as licensed healthcare providers capable of working with private health insurance and personal injury. There are many cohesive organizations that are working very hard to raise the standard for education and practice across the country. We support the raise in this bar, we are a NCBTMB assigned school, we carry membership and liability coverage through ABMP and we are already required to meet a competitive educational standard ourselves as licensed therapists and instructors of massage, but MUCH of our ability to participate and move freely within our national career structure relies on the fact that our education carries DOE approval. This bill would be a step away from what the rest of the nation is working towards in order to bring greater support and legitimacy to our field. It would cripple the small vocational schools ability to be effective to our community or to even sustain a for profit business model.

Again I write in strong **opposition** to this bill in favor of additional discussion on how to better serve our community and small businesses.

Opposition to S.B. 1286, Relating to the Licensing of Private Trade, Vocational, and Technical Schools

Honorable Chairpersons and Members of the EDU & CPH Committees:

The Pacific Center for Awareness and Bodywork has provided quality vocational education for Hawai`i residents and has been licensed by the DOE for 25 years. We support the career development of Hawai`i residents, and our national reputation also brings mainland dollars to the state by attracting students from most US states and Canadian provinces. Unlike most US massage schools in 2017 that have dropping enrollment numbers, we have a waiting list for admission. Our students hear of us primarily via word-of-mouth due to our reputation for offering an advanced training program that integrates bodywork, neuroscience, and extensive communication skills that are not offered anywhere else in the country. I strongly oppose SB1286 because it kills our business in 2017 by making it impossible to obtain a DOE license, which we need to operate.

Perhaps the DOE has too large of a workload and perhaps some unaccredited schools don't need a DOE license to operate, but the solution is not throwing unaccredited schools that DO require DOE licenses to the curb, which is what this bill does. The DOE should keep ALL the schools that depend on a DOE license, not just those that require Title IV funding.

The following outlines the specific reasons for my opposition.

- 1. Unaccredited massage schools also require a DOE license to survive. Schools that receive Title IV funding are not the only ones that need a DOE license in order to function. A DOE license is necessary so that massage graduates can have their transcripts accepted in any state where they apply for a massage license. Transferability is one of the most important factors in a student's decision to enroll. Massage education in Hawaii that is not obtained from a DOE-licensed program is not transferrable to most states, so without the DOE license we cannot attract enough students to have a successful business or give graduates career options outside of the state.
- 2. It negatively impacts students' ability to afford school and begin their careers. Raising the application fee from \$50 to \$10,000 and requiring accreditation, which also costs at least \$10,000, will increase out-of-pocket costs for students. Such an addition to tuition, which is already challenging for most students, would prevent many would-be students from taking this first step in their careers.
- 3. Closing massage schools will mean fewer economic options for Hawai`l residents. Closing vocational massage programs in Hawai`i will mean that more massage students will travel to the mainland for their education, and spas will have to hire more graduates from the mainland.
- 4. Requiring accreditation while charging \$10,000 for nothing is tantamount to extortion. If the DOE won't be reviewing the vocational curriculum and is giving this job to the accreditation agency, then what is this \$10,000 used for? We shouldn't have to pay BOTH the DOE and the accreditation agency for doing quality control. Drop one or give the schools a choice between them.
- 5. **Requiring small schools to be accredited is unnecessarily burdensome**. Standards are important, but small schools do not have the human resources to designate to the enormous task of accreditation. This is especially true if the large amount of paperwork for the DOE application is not

reduced to become congruent with the small amount of effort that the DOE wants to allot to reviewing its contents. Accreditation will only create burdensome bureaucratic busywork and paper pushing and likely lessen the quality of education in schools by devoting our few resources away from student enrichment and program development. Furthermore, if licensing requires accreditation, but accreditation requires licensing, there's no way to get either if one of these is missing by the effective date.

- 6. The September 2017 date is beyond burdensome--it's impossible and unethical. The process of accreditation, even if it moved along at the fastest possible speed (which it wouldn't for us since we would be busy conducting classes through June), could NOT be accomplished by September 1, 2017, much less June 30, 2017 when the next DOE applications are due. The accreditation agency needs to schedule site visits when the school is in session, which wouldn't be possible for us until January 2018 at the earliest since we do not have classes from June to January. In addition, we wouldn't have classes to visit in 2018 unless we already had DOE approval beyond September 2017. Furthermore, in order to accommodate the extra costs for accreditation and licensing, we would likely have to boost enrollment numbers, which are currently capped by facility size. Thus, we would need to find a new facility, which is a nearly impossible task on Kaua'i and would likely take many years to accomplish. Giving businesses enough time to adapt is basic courtesy and common sense. If this bill passes with an effective date prior to September 1, 2019, I will instigate or join a class action suit against the State for damaging my business and my family's livelihood.
- 7. The bill is designed only for the DOE, not for Hawai'l residents. When I read this bill, my sense is that the authors don't care about vocational school education or the school owners, school employees, trained graduates, and the communities they all serve. The only focus is the DOE workload. There's no option provided for non-accredited schools other than to close their doors. Five-year business plans of many, including myself, are instantly reduced to 5-month plans. What good is the mission "to serve and protect the public" if the result of that attempt is to force quality education programs out of existence? Is the State really okay with forcing all Hawai'i massage schools out of existence when they offer such a viable career choice for residents of our tourism-based economy? Is the State really okay with forcing residents to the mainland for their education and giving more vocational jobs to mainlanders?

I urge you to defeat SB1286.

- It takes DOE licenses away from schools that need DOE licenses.
- It will reduce vocational education options for residents, closing almost all massage schools.
- It will make entry into vocational schools less financially feasible.
- It forces unreasonable and unethical expenses onto schools.
- It forces burdensome and unnecessary paperwork onto schools.
- It has an unreasonable and unethical timeline.

But if you are going to pass it for the DOE, please amend it with the following two changes:

- 1. **Give schools a choice between requiring accreditation and raising the fee to \$10,000.** Keep the DOE application fee near \$100 for accredited schools and find a less drastic amount than \$10,000 for the non-accredited ones (or scale the fee up gradually).
- 2. **Set a reasonable timeline.** Change the date from September 1, 2017 to September 1, 2019 if dropping the accreditation requirement or to September 1, 2023 if keeping the accreditation requirement. Don't put us out of business in 2017.

Honorable Chairpersons and Members of these Committees:

I am Margaret Williams, The Administrator of Hawaii Institute of Hair Design, a Private Postsecondary School currently licensed by the Department of Education, State of Hawaii. The Hawaii Institute of Hair Design is accredited by the Accrediting Commission of Career Schools and Colleges. Our students receive Title IV Aid if they qualify. I oppose the removal of Non-Accredited Schools from Private Trade, Vocational and Technical School licensure by the Department of Education. I oppose this bill in its entirety.

The Department of Education has been efficiently issuing licenses to schools for decades. In the past, it took only a few weeks of time for two persons to do the reviews necessary for licensing and renewing schools. Those reviews are done in the slower summer months. The Department of Education should continue to do their job, protecting the older children of Hawaii.

The state authorizes all of the public college programs, why remove licenses from private school programs? This would give the public sector and community

colleges a monopoly. Private cooking and pastry, massage and acupuncture, auto mechanic, medical, healthcare, maritime, barber, grounds maintenance and food service, computer, business applications workplace skills, and accounting are taught at DOE licensed schools. The community college career and technical education programs are authorized by the Board of Regents under the State Constitution. Many of the programs offered by the private schools are also taught at the community colleges. The students at the community colleges have the backing and protection of the state and the constitution, Why not at the private schools? What makes the students who have chosen to get their education at private schools any less worthy of state oversite than of those attending a school that is public? All students should be able to attend school under the security of a state authority overview. No other government agency wants to take on the extra responsibilities. The DOE has been able to complete the school reviews efficiently and should continue to do their job. (Utilizing just a few weeks of two staff members time.) State licensure is a stepping stone towards National Accreditation. Without a license, how will these schools achieve accreditation, The bill would create a restrictive monopoly for established accredited schools and the community colleges No future unlicensed schools could ever achieve National Accreditation..

The bill is speaking of turning the student complaints over to RICCO. I believe RICCO accepts only complaints on licensed trades. Cooking, business, food service, computers, etc. are not DCCA licensed fields. Would RICCO accept and investigate complaints on these programs?

If is this legislation just throwing caution to the wind and allowing every Tom, Dick, and Harry to open a school without a license, causing them to try to open, charge tuition, and end up closing the schools, running off with their students' hard earned money because they were not prepared to succeed, did not have rules to prepare to run a school properly: rules like, curriculum, financial stability,

integrity in reputation, floor plans, health, fire and building dept. approval, experienced teachers. We need to protect Hawaii's students from fraud!

Why should the license and renewal fees be \$10,000.00? How would the state use the fund? Although the unaccredited schools are smaller, all of the Accredited Schools in Hawaii are not large. HIHD has 67 students and the last time I checked, Med Assist had 35 and Travel Institute had 68. The really large colleges with hundreds of students can afford such fees. Smaller schools will struggle. The state pays for the Community college oversee; can the taxes we pay not cover our fees? Unlike the public Colleges, the Private Postsecondary Schools do not ask the state to pay our teachers or for maintenance of our buildings. We are doing the state a service in educating the children of Hawaii, getting them to work, and keeping many out of prison or off the welfare rolls.

The standard definition of "license" is "a permit from an authority to own or use ….do a particular thing or carry on a trade". It is not practical to legislate a new definition in a bill like this one.

This bill should take effect in September of 2017. Licenses expire on August 31, 2017 and must be continuous. Continuous renewal would not be possible, even for the accredited schools, if the Renewal applications do not arrive until after the bill takes effect.

I am so pleased to see that this bill recognizes that Accredited Schools need the DOE licensure to keep financial Aid available for our students. Thank you very much.

And thank you for hearing my concerns. Please continue to protect the people who are not college bound and chose to learn to become employable by attending a private school. Please have the DOE do their job and defeat this bill

Comments: February 6, 2017 Re: SB1286 Bill - DOE licensure for Vocational and Trade Schools Dear Representatives, My name is Cynthia E. Rose, and I am writing in representation of the Maui Academy of Healing Arts. We are a vocational school for massage therapy licensure for the State of Hawaii, in operation since 1988. I am writing to declare opposition to the current bill set for hearing on Wednesday Feb. 8th, in regards to the DOE's revised proposals for licensure to local trade and vocational schools. The effect of this proposal would have devastating consequence to our ability to provide this educational alternative to the community. For decades MAHA has operated in compliance with the DOE in order to provide a high standard alternative education to not only the local community, but students from all the across the US and even internationally. We provide education opportunities to veterans through VA funding, international students, Native Hawaiian students via the Alu Like scholarship, and even most currently through scholarships from the local womens shelter to victims of domestic violence. Although we may continue to provide some of these services, our school also depends on the diversity of students coming from different regions to train and perhaps return to their respective states and be able to transfer their DOE approved education credit to their licensing board so that they may legally practice their trade and retain the value of their education. I believe is also necessary to have this approval to maintain our VA program. We support the ability for the DOE to administer to us, and are willing to negotiate to have that administration continue, however the proposed bill SB1286 is not only burdensome and untimely, but frankly, borders extortionist in its fee revision and expectation. NO small vocational school will be able to meet and comply with the proposal set forth, much less maintain the exorbitant application and renewal fees. These fees are burdensome in the extreme. The DOE also in asking for these fees, demands that we in tandem maintain OUTSIDE accreditation with a third party agency (in our case this would be COMTA.org) which also carries a massive application fee, and renewal fees. If the DOE is not interested in regulating the curriculum for our vocational programs and demands it be accredited by an alternate agency so that they meet a standard, why are we paying an additional 9,000\$ every two years to the DOE to administer to us? Why not just request accreditation or some alternative requirement? At the very least this needs further testimony and negotiation. This bill would give our

school 7 months to come into compliance with almost 70,000\$ in fees and bonds, and demand that we obtain accreditation from an outside source that can take more than a year to finalize. Concurrently, if a vocational would wish to pursue this process in any time frame outside of their current valid DOE licensure, for instance if more time was needed to manage the large fee submission and create a functioning administration to meet these new requirements....they could expire their current DOE approval, not be able to renew it, and in turn NOT be able to apply for accreditation by a third party agency because they require valid DOE licensure. As proposed, this would shut down the ability ongoing for ANY school to comply, at least within our field. This does not even begin to address the personal administrative burden each school would have to take on in order to document and comply with federal agencies regarding student aid, and maintenance of third party accreditation. All of our curriculum would be monitored by an outside agency and we would in essence be paying the DOE an exorbitant rate to do very nearly what it does now. This is unacceptable. Lastly, if we chose not to meet these outrageous proposals for licensure, we would lose the diversity of our student body, and practitioners gaining Hawaii licensure would lose their ability to maintain a license if they ever needed to work or live on the mainland, or apply for additional certifications. Massage Therapy is rapidly growing and evolving into a highly respected adjunct healthcare modality. In many states practitioners are now legally accepted as licensed healthcare providers capable of working with private health insurance and personal injury. There are many cohesive organizations that are working very hard to raise the standard for education and practice across the country. We support the raise in this bar, we are a NCBTMB assigned school, we carry membership and liability coverage through ABMP and we are already required to meet a competitive educational standard ourselves as licensed therapists and instructors of massage, but MUCH of our ability to participate and move freely within our national career structure relies on the fact that our education carries DOE approval. This bill would be a step away from what the rest of the nation is working towards in order to bring greater support and legitimacy to our field. It would cripple the small vocational schools ability to be effective to our community or to even sustain a for profit business model. I oppose Bill SB1286.

I am a licensed massage therapist in the State of Hawaii and attended a small school on the Big Island of Hawaii, HISBT, where I received a world class education. At the time we were considered one of the top 5 massage schools in the country.

Had this proposed Bill SB1286 been in force my school may not have existed. After speaking with the owners of a few Massage Schools, I am convinced that they will not survive the licensing fees and accreditation fees levied by this proposed Bill SB1286 as most of these schools have quite a small student body. No doubt the fees would fall upon the students tuition. The schools would likely close leaving us with Apprenticeship Programs as the only way to get licensed in this State of Hawaii. Quite honestly, the way this Bill is written it considers fees and management of fees more than the impact on and understanding of how a Massage School actually operates.

At a minimum, please allow for more input from the Massage Schools which will be affected to come to a viable plan to insure quality of education and practicality of the business surviving. Also, please allow the schools that are currently operational to have more time to come into compliance with whatever is ultimately agreed upon.

Re: Opposition to Bill SB1286 - DOE licensure for Vocational and Trade Schools

Dear Representatives,

My name is Frances Salvato, and I am the Director of Education at the Maui School of Therapeutic Massage (MSTM) located in Makawao, Hawaii. MSTM is a vocational school for massage therapy licensure in the State of Hawaii, in operation since 1995. I am writing to declare my **opposition** to the current bill set for hearing on Wednesday Feb. 8th, in respect to the DOE's proposed changes to licensing requirements for Hawaii's trade and vocational schools.

The effect of this proposal would have devastating consequence to our ability to provide this education in our community. For decades MSTM has operated in compliance with the DOE in order to provide a high standard of education, not only for our local community, but for students from all the across the US and the world.

We have provided education opportunities to veterans through VA funding, Native Hawaiian students who receive Alu Like scholarships, victims of domestic violence via scholarships from local women's shelters, and we provide student visas to our international students. We need DOE license to maintain our VA program and to provide student visas. Due to our island's small population, our school depends on attracting students from other states who plan to return home after training. They must use their DOE licensed school credits to qualify for their state's license, to legally practice their trade and retain the value of their education.

We support the DOE's administration of our school, and want that administration to continue, but the proposed bill SB1286 would cause crushing increases to our licensing fees. This is discriminatory toward small businesses. No small vocational school will be able to meet and comply with the proposed requirements as set forth, or afford the exorbitant fees for application and renewals. These fees are oppressive for small businesses such as ours. The proposal also demands that we maintain outside accreditation with a third party agency (in our case this would be COMTA) which also charges massive application and renewal fees. If the DOE does not wish to regulate the curriculum for our vocational programs and instead requires accreditation by an alternate agency, what is the reason for charging an additional \$9,000 biannually? At the very least this needs further discussion and negotiation.

The bill would give our school only 7 months to comply with COMTA requirements and obtain their accreditation which takes well over a year to finalize, plus almost \$70,000 in fees and bonds! There is a catch 22 for a vocational school that can't accomplish accreditation in this impossible timeframe or afford the exorbitant fees: they would lose their current DOE license and would not be allowed to renew it, and then their accreditation would be denied for lack of a DOE license! As proposed, this bill would prohibit any new schools from qualifying for accreditation, at least in the massage therapy field.

This does not even begin to address the personal administrative burden each school would have to take on in order to document and comply with federal agencies regarding student aid, and the multitude of other requirements for maintaining accreditation. All of our curriculum would be monitored by an outside agency and we would be paying the DOE an exorbitant rate to do very nearly what it does now. This is unacceptable.

If we chose not to meet these onerous licensing requirements, we'd lose diversity in our student body, and practitioners with a Hawaii LMT license would no longer be able to relocate to the mainland and become licensed in other states, or apply for National Certification as they can now.

Over the last few decades, Massage Therapy has grown rapidly and evolved into a highly respected adjunct healthcare modality. In many states and countries, massage practitioners are now legally accepted as licensed healthcare providers for private health insurance, auto insurance, workers compensation, and personal injury claims. There are many cohesive organizations working hard to raise educational standards across the country and define our scope of practice and standard of care. We support raising the bar; we are a NCBTMB assigned school; we carry membership and liability coverage through ABMP, and we are already required to meet competitive educational standards as licensed therapists and instructors of massage. As therapists, our ability to participate and move freely within our national career structure relies on the fact that our school has a DOE license. This bill would be a step away from what the rest of the nation is working towards to bring greater legitimacy to our field. It would cripple the small vocational schools and leave only large institutional owners who are not even practitioners themselves, but motivated only by profit without any understanding of the profession.

I'm opposed to Bill SB1286 and would like to see more discussion on how to better serve our community and small businesses.

Comments: Dear Representatives, As a recent graduate of the Maui School of Therapeutic Massage (MSTM) I am writing to voice my opposition to SB-1286. I want to express my satisfaction with the current system, and my opposition to the changes that SB-1286 will likely bring as follows: 1. My school provided an excellent education: Let me first say that my quality of education at MSTM was excellent. I am currently in Canada, and am living with my wife who is going to school here to become a registered massage therapist. Canada has probably the most rigorous schooling for massage therapy in the world, requiring between 2000 and 3500 hours of training. I can tell you that my training at MSTM, while briefer, equals or exceeds the training my wife is receiving on a per content basis. We had more instructors, with more experience, and learned a number of massage approaches and paradigms which I value greatly, yet my wife will only touch upon in her program. 2. My excellent education was affordable (I was able to attend without taking out student loans): My school, MSTM, can remain price competitive in the global education market, which draws students from all over the world to enrich the HI state economy and culture. My school is able to stay competitive because their licensing fees are very reasonable in the State of Hawaii. SB-1286 will likely increase the fees for my school in a very unreasonable way. From what I understand, the current fees are \$50 and SB-1286 would open the door for them to increase from \$50 to \$10,000! In addition the fees to get certified via a third party such as COMTA would be an additional sum of \$10,000 plus annual fees! This is just not acceptable or wise, and seems like a requirement that is designed to put small schools out of business. Small independent schools cannot afford these high rates and many would go out of business which would harm the Hawaii state people's educational options and economy, as well as harm the educational options of citizens from all places who might otherwise come to Hawaii for schooling like I did. 3. SB-1286 will harm the Hawaii state economy greatly: I can tell you that I would not have come to HI to study and spend my money had the price of the education options been too high. I know that many of my fellow students would say the same. I do not have statistics, but I can only imagine that the total economic benefit to HI of it's many small, independent schools must easily be in the many millions of dollars across all the islands. The more students pay for school, the less they spend at the market. The more small business

shut down, the more people in Hawaii will be without a job. How many people work for small schools across all the islands? I imagine the numbers are in the thousands. SB-1286 risks putting them out of work, and for what gain? I cannot understand the motivation of this bill. Who is it helping? 4. SB-1286 will likely force my school and most other schools to shut down: Based on my understanding of SB-1286 it will impact most small schools in Hawaii by shutting them down due first to exorbitant costs and second to unrealistic timelines. This is simple a shame, and we must avoid this. 5. Hawaii Department of Education (DOE) is the appropriate agency to handle school licensure: I argue that if the DOE doesn't want to maintain this responsibility, which arguably makes sense given their role, then the alternative put in place should protect the viability of small schools. I believe that another solution can be found that meets everyone's legitimate needs, including the DOE, but that the current bill simply absolves the DOE of it's role while punishing small, independent schools and the citizens they serve. Final thoughts: My education at MSTM was not only excellent, but life enhancing and life changing. I now have a skill that I can use to help people achieve better health. This is something I am very proud of. To think that my school will likely go out of business for bureaucratic reasons when they are doing such an excellent job is heartbreaking. Re: Opposition to Bill SB1286 - DOE licensure for Vocational and Trade Schools

Dear Representatives,

My name is Linda Sola, and I am the founder and director emeritus of the Maui School of Therapeutic Massage (MSTM) located in Makawao, Hawaii. MSTM is a vocational school for massage therapy licensure in the State of Hawaii, in operation since 1995. I am writing to declare my **opposition** to the current bill set for hearing on Wednesday Feb. 8th, in respect to the DOE's proposed changes to licensing requirements for Hawaii's trade and vocational schools.

The effect of this proposal would have devastating consequence to our ability to provide this education in our community. For decades MSTM has operated in compliance with the DOE in order to provide a high standard of education, not only for our local community, but for students from all the across the US and the world.

We provide education opportunities to veterans through VA funding, Native Hawaiian students who receive Alu Like scholarships, victims of domestic violence via scholarships from local women's shelters, and we provide student visas to our international students. We need DOE license to maintain our VA program and to provide student visas. Due to our island's small population, our school depends on attracting students from other states who plan to return home after training. They must use their DOE licensed school credits to qualify for their state's license, to legally practice their trade and retain the value of their education.

We support the DOE's administration of our school, and want that administration to continue, but the proposed bill SB1286 would cause crushing increases to our licensing fees. No small vocational school will be able to meet and comply with the proposed requirements as set forth, or afford the exorbitant fees for application and renewals. These fees are oppressive for small businesses such as ours. The proposal also demands that we maintain outside accreditation with a third party agency (in our case this would be COMTA) which also charges massive application and renewal fees. If the DOE does not wish to regulate the curriculum for our vocational programs and instead requires accreditation by an alternate agency, what is the reason for charging an additional \$9,000 biannually? At the very least this needs further discussion and negotiation.

The bill would give our school only 7 months to comply with COMTA requirements and obtain their accreditation which takes well over a year to finalize, plus almost \$70,000 in fees and bonds! There is a catch 22 for a vocational school that can't accomplish accreditation in this impossible timeframe or afford the exorbitant fees: they would lose their current DOE license and would not be allowed to renew it, and then their accreditation would be denied for lack of a DOE license! As proposed, this bill would prohibit any new schools from qualifying for accreditation, at least in the massage therapy field.

This does not even begin to address the personal administrative burden each school would have to take on in order to document and comply with federal agencies regarding student aid, and the multitude of other requirements for maintening accreditation. All of our curriculum would be monitored by an outside agency and we would be paying the DOE an exorbitant rate to do very nearly what it does now. This is unacceptable.

If we chose not to meet these onerous licensing requirements, we'd lose diversity in our student body, and practitioners with a Hawaii LMT license would no longer be able to relocate to the mainland and become licensed in other states, or apply for National Certification as they can now.

Over the last few decades, Massage Therapy has grown rapidly and evolved into a highly respected adjunct healthcare modality. In many states and countries, massage practitioners are now legally accepted as licensed healthcare providers for private health insurance, auto insurance, workers compensation, and personal injury claims. There are many cohesive organizations working hard to raise educational standards across the country and define our scope of practice and standard of care. We support raising the bar; we are a NCBTMB assigned school; we carry membership and liability coverage through ABMP, and we are already required to meet competitive educational standards as licensed therapists and instructors of massage. As therapists, our ability to participate and move freely within our national career structure relies on the fact that our school has a DOE license. This bill would be a step away from what the rest of the nation is working towards to bring greater legitimacy to our field. It would cripple the small vocational schools and leave only large institutional owners who are not even practitioners themselves, but motivated only by profit without any understanding of the profession.

I'm opposed to Bill SB1286 and would like to see more discussion on how to better serve our community and small businesses.

However, the school I attended 22 years ago was a DOE approved school, and were it not for their level of education, I might not be where I am today. I think it is important for students to have choices, and while the tuition at DOE schools is more expensive, they are able to offer a wider scope of classes, that fit some students needs better. Some students chose a DOE school as they are recognized nationally, so the students are able to transfer hours for licensure in most states. For my students it's hit or miss, and I let them know before enrolling that it's primarily a Hawaii State Licensing program and may not be accepted in other states. If that's really important to them, I encourage them to find a DOE approved school. With the transient nature of many people who move to Hawaii, I think it's important that people are given all the information, and have options. It appears that this bill would make it unprofitable for most vocational schools licensed with the DOE to stay in business.

I am a middle-class, Hawaii-born resident and young father. Because of the affordability and world-class quality of education of the vocational school which I attended (Maui School of Therapeutic Massage), I am now a Licensed Massage Therapist and am capable of supporting my family in the competitive Hawaiian job market. If vocational schools are required to pay the proposed new and increased fees for their own licensing, many would likely be forced to shut down, and those which remained open would have to charge higher rates of tuition, which would effectively disqualify a wide margin of struggling locals who are barely making ends meet from entering vocational studies and improving their career options.

With all due respect, are the lawmakers at work here asking themselves who this bill would benefit most? Would it actually increase the "sustainability" of educational programs? Or, would it streamline the bureaucratic process at the expense of the scrappy but opportunity-starved local community?

In today's political climate, our lawmakers should perhaps be asking themselves more than ever: Are we truly proposing rules that would increase the vitality of the middle-class and pave the way for economic equity in today's Hawaii (which has grown carnivorous to the extreme)? Even while morality should always pose this question, dignity and self-preservation might do so as well, because right now the people are very awake and growing more organized by the minute. Any policies that clearly do not reflect the striving toward the betterment and enablement of our local community and economy will undoubtedly be vehemently, persistently, and publicly opposed. Why bother passing this bill in the first place, when a media-friendly counter-movement will surely arise and likely lead to a subsequent apology, repeal, and embarrassing loss of face?

The Maritime License Center has been approved to receive Workforce Investment Act (WIA) funds and Post 9/11 GI Bill, Veterans Administration funds.

In order to receive these funds, the Maritime Licensed Center had to show that it was licensed by the state.

SENATE BILL 1286 & HOUSE BILL 494 CONCERNS

• "Purpose of the Act" To narrow the scope of the licensing program and establish a licensing fee to ensure the program's sustainability.

The Act has been narrowed – Sections 427 and 428 have been eliminated which eliminates most of the DOE responsibilities with regard to schools and raises the cost of licensing from \$50.00 to \$10,000.

• "302A" Special Fund to fund fund activities related to licensure requirements.

Most of these activities have eliminated (Sections 427 & 428 of the Act)

- "302A-425 licensing of private trade, vocational or technical schools"
- "SECTION 3. Sections 302A-101 amended as follows _____ except"
 - (3) Flying schools qualified under the Federal Aviation Administration

What about Maritime School Programs/Courses qualified under the USCG National Maritime Center?

- "302A-425 License only those schools authorized by the state to be considered for Title IV of 1965/Title 34 student aid programs. (1) Certification on official letterhead of the school, that the school has students currently receiving, or who have applied to receive aid under title IV of the higher Education act of 1965" (2) Proof that the school is accredited by an accrediting commission ______"
 - (1) The Maritime License Center has not applied for and does not receive funds from this program (student grants & loans) but does qualify for and receive Workforce Investment Act (WIA) funds and Post 9/11 GI Bill, Veterans Administration funds and must be State licensed in order to maintain these qualifications.
 - (2) The Maritime License Center has USCG National Maritime Center approved courses, but as stated earlier, the USCG does not approve schools. Upon completing my courses, the student applies for and receives a USCG masters (Captains) license allowing he/she to captain a vessel on any U.S. waters.

SUMMARY OF CONCERNS

From the above it appears that the Maritime License Center (MLC)does not qualify to be licensed by the state of Hawaii and will lose their WIA and VA qualifications. Without these funds the MLC may very well have to go out of business

The \$10,000 fee is prohibitive to small businesses like the Maritime License Center. The Department of Transportation (DOT Harbors Division) has this past year taken away our Lifeboat/Water Survival facility at pier 24 and told us to move to Barbers Point Harbor at (a cost of over \$5 0,000) but has yet to give me a new location at Barbers Point for this facility.

The Maritime Industry is vital to Hawaii. The service that the MLC provides to the Hawaii Maritime Industry, allows this industry to bring in millions of dollars to the Hawaii economy. If the MLC went out of business due to this bill, the cost to Hawaii mariners to obtain and maintain their licenses would in the hundreds of thousands of dollars. They would have to travel to the mainland to take the USCG required training. In addition to the cost is the time away from family which is already a tremendous burden to mariners who are at sea for weeks at a time.

RECOMMENDATIONS

- Put the Maritime Industry in the same category as the Airline industry schools and/or reword the bill to include licensure for schools who have courses approved by the USCG National Maritime Center.
- Reduce the licensing fees to a reasonable rate (under \$500) to cover the administrative costs of licensing. Almost all of the other functions that the DOE use to be responsible for have been eliminated by the bill.

Aloha mai kaua,

I am opposed to SB1286 because of prospective damaging outcomes for Hawai`i, e.g., to the Maui School of Therapeutic Massage in Makawao. Devastating increases in vocational schools' licensing fees would result in a loss of vocational schools and a loss of practitioners in, as with massage-therapy schools, a burgeoning health-care field.

First, the proposal demands that such schools maintain outside accreditation with a third party agency — Commission on Massage Therapy Accreditation, or COMTA, in the case of massage-therapy schools — that would raise such institutions' application fee from \$50 to \$70,000 in fees and bonds.

Second, the bill would give such vocational schools seven months to comply with COMTA requirements and to obtain accreditation, which takes more than a year to finalize.

Finally, each school administration would assume a documentation burden to comply with 1) federal agencies regarding student aid and 2) numerous other requirements to maintain accreditation. An outside agency would monitor all curriculum, while schools would pay the DOE an exorbitant rate to do very nearly what it does now.

In conclusion, SB1286 deserves a failing grade for its prospectively crippling 1,400-fold increase in vocational schools' application and licensing fees that would lock their doors and turn away their students.
