#### RE: S.B. 324; RELATING TO ABUSE CRIMES.

Chair Keith-Agaran, Vice-Chair Rhoads, and members of the Senate Committee on Judiciary and Labor, the Department of the Prosecuting Attorney, City and County of Honolulu, submits the following testimony in support of the intent with concerns.

The purpose of S.B. 324 is to protect individuals who are the victims of negligent or reckless conduct when operating a vehicle. Although our Department supports the intent of this bill, the proposed amendment appears to be duplicative. Currently, manslaughter, section 707-702(a) of the Hawaii Revised Statutes addresses this type of conduct when committed with or without a vehicle:

707-702 – Manslaughter – (1) A person commits the offense of manslaughter if:

- (a) A person recklessly causes the death of another person; or
- (b) The person intentionally causes another person to commit suicide.

Thus, S.B. 324 appears to create an identical charge, with the additional element of committing the offense when operating a vehicle. In addition, manslaughter is classified as a class A felony, whereas the proposed amendment would be for a class C felony. Nevertheless, if the Legislature believes the proposed amendment is necessary, our Department would urge this Committee to make a similar amendment to 707-702.5(a), to ensure consistency between the different degrees of this offense.

For all of the foregoing reasons, the Department of the Prosecuting Attorney, City and County of Honolulu supports the intent of S.B. 324, with the concerns noted. Thank for you the opportunity to testify on this matter.

## TESTIMONY ON SB 324 - RELATING TO CRIMES

Chair Keith-Agaran, Vice Chair Rhoads and Members of the Committee:

The Department of the Prosecuting Attorney, County of Maui strongly opposes SB 324. This measure adds operating a vehicle in a reckless manner to the offense of negligent homicide in the second degree.

Currently, reckless operation of a vehicle resulting in death falls under Manslaughter, a class A felony. This bill will decrease the level of the offense to only a class C felony. This will seriously undermine traffic safety efforts, and make safe and prudent operation of vehicles on our roadways less important.

Accordingly, the Department of the Prosecuting Attorney, County of Maui, requests that this measure be HELD.
