TESTIMONY FOR SENATE CONCURRENT RESOLUTION 102/SENATE RESOLUTION 46, ENDORSING AND ADOPTING, AND URGING THE SEVERAL COUNTIES TO ENDORSE AND USE, THE UNITED NATIONS SEVENTEEN SUSTAINABLE DEVELOPMENT GOALS AS COMPONENTS OF A FRAMEWORK FOR ADDRESSING AND ASSESSING HAWAII'S EFFORTS TOWARD SOCIAL JUSTICE AND SUSTAINABILITY

Honorable Chair Nishihara, Chair Rhoads, and committee members:

I am Kris Coffield, representing IMUAlliance, a nonpartisan political advocacy organization that currently boasts over 350 members. On behalf of our members, we offer this testimony in strong support of SCR 102/SR 46, endorsing and adopting, and urging the several counties to endorse and use, the United Nations seventeen sustainable development goals as components of a framework for addressing and assessing Hawai'i's efforts toward social justice and sustainability.

The United Nations Sustainable Development Goals (SDGs), officially known as Transforming our world: The 2030 Agenda for Sustainable Development, is a set of 17 "Global Goals" with 169 targets between them. Authored by the UN in consultation with numerous international organizations and government agencies, the goals were adopted in 2015 as part of a broader intergovernmental agreement that acts as the Post-2015 Development Agenda (the successor to the Millennium Development Goals), building on the principles established under Resolution A/RES/66/288, popularly known as "The Future We Want." As former UN Secretary-General Ban Ki-moon frequently asserted prior to the SDGs enactment, "we don't have plan B because there is no planet B."

Thus, for UN member states, sustainability and social justice go hand-in-hand. Yet, the current United States executive administration embraces neither. Both President Donald Trump and Environmental Protection Agency Administrator Scott Pruitt reject the overwhelming scientific consensus that manmade climate change is real and largely caused by burning coal, oil, and natural gas. They vehemently denounced the Paris Agreement, which aims to advance the United Nations Framework Convention on Climate Change by:

- "(a) Holding the increase in the global average temperature to well below 2 °C above pre-industrial levels and to pursue efforts to limit the temperature increase to 1.5 °C above pre-industrial levels, recognizing that this would significantly reduce the risks and impacts of climate change;
- (b) Increasing the ability to adapt to the adverse impacts of climate change and foster climate resilience and low greenhouse gas emissions development, in a manner that does not threaten food production;
- (c) Making finance flows consistent with a pathway towards low greenhouse gas emissions and climate-resilient development."

The agreement has been described as an incentive for and driver of fossil fuel divestment, with the global peaking of greenhouse gas emissions an ultimate goal of ratifying nations.

Finally, Pruitt has endorsed and declared that President Trump will sign an executive order Tuesday—the date that this resolution is being heard—to roll back the Obama Clean Power Plant initiative, which aims to curb greenhouse gas emissions from coal-fired power plants. While Pruitt believes the order will bring back lost coal and manufacturing jobs and result in lower electricity rates for Americans, the 2015 Clean Power Plan rule was designed to strengthen clean energy generation by setting standards for power plants—particularly coal-burning power plants—and goals for states to cut carbon dioxide pollution. In attempting to reduce carbon dioxide emissions from electrical power generation by 32 percent within twenty-five years relative to 2005 levels, the Clean Power Plan rule would create thousands of clean energy jobs nationwide.

Hawai'i is the nation's leader in clean energy, having set a goal of becoming 100 percent renewable reliant by 2045. We must take a stand to ensure that our public policy continues to protect our planet from the industrial processes and corporate gluttons that threaten its survival. Mahalo for the opportunity to testify <u>in support</u> of this resolution.
