Re: Testimony of the Hawaii State Ethics Commission with **COMMENTS** on

SCR 140/SR61, Urging the Board of Education to Restrict Any Person from Applying for the Position of Superintendent of Education if that Person was a Member of the Board of Education when the Search and

Hiring Process was Developed or Initiated

Dear Chair Kidani and Committee Members:

The Hawaii State Ethics Commission ("Commission") takes no position on this measure, but hereby submits comments on how the Ethics Code applies in these types of situations.

The State Ethics Code prohibits an employee¹ from, among other things, using his/her position to give him- or herself an unwarranted advantage. Specifically, the statute's "fair treatment" provision provides in relevant part: "No legislator or employee shall use or attempt to use the legislator's or employee's official position to secure or grant unwarranted privileges, exemptions, advantages, contracts, or treatment, for oneself or others[.]" Relatedly, the Ethics Code's "conflicts of interest" provision, HRS section 84-14, prohibits an employee from taking any "official action" involving "[a] business or other undertaking in which the employee has a substantial financial interest[.]" For example, an unpaid Board/Commission member cannot vote to hire him- or herself (or the Board/Commission member's spouse) for a paid position.

The Ethics Commission believes that the both the fair treatment and conflicts of interests laws may apply in a situation where a sitting Board/Commission member applies for employment with that Board or Commission. Together, these laws prohibit self-dealing and, generally, the misuse of one's official position.

Several years ago, when similar questions arose regarding hiring a new President for the University of Hawaii (and several Regents were mentioned as potential candidates), the Ethics Commission issued Ethics Advisory 2013-03. In it, the Commission advised that a Board/Commission member interested in applying for employment with that agency "resign as a member of the board when he decides to apply for a position that is hired, selected or approved by the board." The Commission continues to advise this course of action for anyone in this type of situation.

¹ "Employee" is defined to include members of boards, commissions and committees. HRS section 84-3. Accordingly, a board member is subject to the State Ethics Code and must adhere to the standards of conduct contained therein. HRS section 84-2.

² This Ethics Advisory does not have the force and effect of law, but does represent the Commission's educational guidance to state officials in these situations to avoid ethics violations.

The Commission stresses that the Ethics Code does not necessarily prohibit an agency from hiring an individual who has recently served on that Board or Commission conducting the hiring. Indeed, the Commission supports agencies' efforts to employ the most highly skilled and qualified candidates; it may be the case that, for any given position, the best candidate for a particular position is an individual who has served on the Board/Commission responsible for hiring. The Ethics Code does not necessarily prohibit hiring an internal candidate, provided that the applicant complies with the fair treatment and conflicts of interests laws. The Commission also recognizes that the point in time at which an individual decides to apply for a position may not always be clear, and may depend upon an individual's subjective intent (though such intent may be gleaned from other sources, such as the individual's statements and/or actions). As such, the Commission strongly recommends that anyone in this type of situation consult with the Ethics Commission as early as possible.

Finally, the Commission respectfully reminds all state officials that the Ethics Code represents the <u>minimum</u> standard of ethical conduct for state employees. Agencies are permitted to set higher standards as they see fit.
