MECHANISM FOR GENERATING WATER CIRCULATION
IN POKAI BAY ON LEEWARD OAHU**

Senate Concurrent Resolution 88 / Senate Resolution 34 urge the United States (U.S.) Army Corps of Engineers and the Department of Land and Natural Resources (Department) to collaborate to create a mechanism for generating water circulation in Pōkaʻī Bay on Leeward Oʻahu. **The Department acknowledges the intent of these measures but respectfully opposes these resolutions due to the lack of jurisdiction and funding.**

The intent of this measure is to address concerns with alleged environmental and health risks caused by pollution and contaminants in Pōkaʻī Bay due to runoff containing industrial pollutants, illegal dumping of dredged materials, and bacteria from members of the public bathing at the bay.

Before discussing ways in which to increase water circulation in Pōkaʻī Bay, the Department believes that a water quality assessment is needed which is beyond the Department's expertise and jurisdiction. In addition, Pōkaʻī Bay Beach Park is under the jurisdiction of the City and County of Honolulu, so addressing concerns with shower runoff affecting sand and water quality at Pōkaʻī at the bay would require their participation.

After a water quality assessment is completed and if improved water circulation is deemed necessary, the Department can work with the U.S. Army Corps of Engineers or acquire the services of a consultant to conduct studies on a possible reconfiguration of the offshore

breakwater. The study would likely assess the structural integrity of the breakwater if redesigned, as well a movement of sand when high surf enters the bay. These studies will require funding, and unfortunately, the Department is unable to support such an effort with our existing operational funds. We respectfully ask that funding be provided to support this effort.

Lastly, the Department notes that it is working to address the issue of boats being moored in the bay for longer than permitted. We are actively working to address this issue through administrative rules.

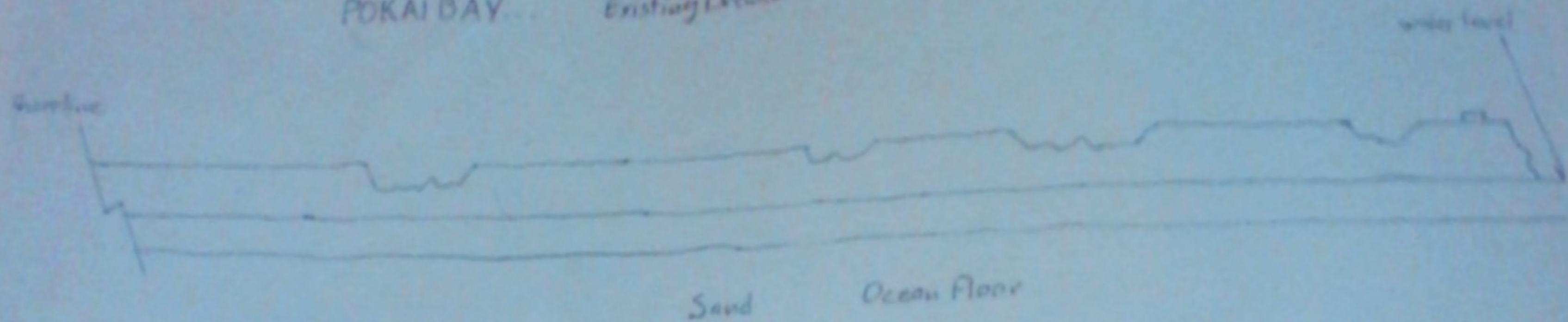

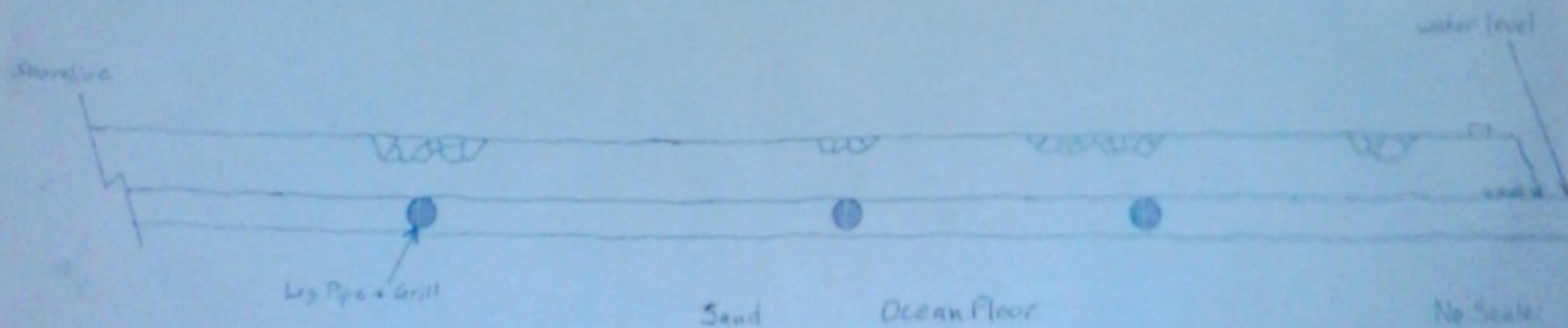

In SUPPORT of SCR88 Relating to Generating Circulation in Poka'i Bay

Aloha Chairman Rhoads, Chairman Gabbard and members of the committees of water & land, and agriculture & environment,

I strongly SUPPORT SCR88 relating to collaboration in generating circulation system in Poka'i, Bay.

Poka'i Bay has become a poisoned due to the economic and environmental stressors that have continued to assault the Wai'anae community since colonization. Poka'i Bay has traditionally acted as a hub for the people of Wai'anae. Besides being the home of Ku'ilioloa Navigational Heiau, Poka'i Bay is host to an array of family and community gatherings as well as land and ocean leisure sports and activities. However, most recently ramifications of stagnant water are compounding with illegal dumping upstream and creating an unsafe environment for Poka'i Bay users. My father has been treated for staph four times within the last two years. Meanwhile, sixteen of his friends have also been treated for staph infections linked to Poka'i Bay. Records from Wai'anae Coast Comprehensive Health Center and Kaiser's Nanaikeloa Clinic should corroborate the high number of staph infections related to contact with Poka'i Bay.

SCR88 must be SUPPORTED because it is time to do the right thing and take care of an island treasure that is growing harmful bacteria and negatively impacting the short- and long- term health and wellness of Wai'anae community members who use Poka'i Bay regularly.
