I. Background and Summary

- 1. X A brief description of the applicant's background; Alaka'i O Kaua'i Charter School (Alaka'i) is a recently approved K-8 public charter school for Kauai. It was a long three-year process to bring this innovative 21st Century School to Kauai. On August 11, 2016, the Hawaii State Public Charter School Commission (Commission) unanimously approved Alaka'i to open August 2017. Because of the difficulty of finding a location, Alaka'i will open August 2018, for it found its home at Mount Kahilli Park in Lawai, HI. Our mission, as a project-based K-6 school is to provide a progressive, innovative curriculum that prepares students for a successful future, teaching to the whole child: academically, socially, emotionally and physical well- being. Alaka'i will be unique from traditional DOE schools in that we will be providing an Individual Learning Plan for each child. Alaka'i has received their five-year contract from the Commission and are raising funds to open our doors to all Kauai keiki (children). We are enrolling 165 students who are Kindergarten 5th graders for our first year and will add a grade each year until we reach K-8 grades.
- 2. X The goals and objectives related to the request; Education of our youth, our future leaders, should be a priority for the nation, and especially for Hawaii. Our educational outcomes are far below the national average and we need to improve education in Hawaii. The Department of Education (DOE) and charter schools are turning to more project-based learning and with this methodology, it is imperative that schools be connected to the 21st Century of technology, environmental and sustainable ways of thinking and producing, and bringing the "real world" into the classroom. Our title, Hanau Alaka'i O Kaua'i Charter School, the birth of a new school for Kauai will begin a transformation in education. We will prepare our keiki with the 21st Century skills of critical thinking (problem-solving), creativity (the arts and free to think), collaboration (working together and with others), communication (technology and researching) and caring (for oneself, others, and society). It is our kuleana to provide this progressive education for our leaders of tomorrow. With this understanding of the need for an innovative way of teaching, there is a high expense, especially our first year of operation. Our humble and respectful request is for the following to fulfill our projectbased approach and use of technology (STEAM – STEM with the arts added):

a. skillful technology/data coordinator that will be able to troubleshoot, inform, and work with students and teachers, technically but also in providing data for improvement;

- b. lease of modern equipment that might be too expensive to purchase our first or second year of operation such as printers, 3-D machine, lasers;
- c. the ability to afford eRate, an expanded service for broadband;
- d. computers, laptops, iPads, and other electronic equipment for administration, staff, students;
- e. software and supplies to enable students to be actively engaged in their learning;
- f. professional development in project-based learning with a three-week intensive workshop before the opening of school (union only allows two days before school outside of classroom preparation and teachers must be paid a stipend beyond the regular scheduled days);
- g. project-based consultants for deeper learning (teachers need training by experts and experienced practitioners that have received positive outcomes and results with their students); and
- h. on-going professional development for administrators, teachers, and staff will be imperative conferences and collaboration with others to continue the learning and sharing that will promote growth in the staff.
- 3. X The public purpose and need to be served;

Education is a public purpose and an urgent need for our youth. We cannot afford to let the rest of the world pass over the next generation of leaders. Education as we know it today is yesterday's model. Our community had 685 signatures of support given to the Charter Commission requesting that Alaka'i be given the chance to provide a free education that is innovative and will make a difference for the educational well-being of their child. Kauai's prominent private school is extremely successful, but charges \$14,000 a year per child for tuition and in addition, collects additional fees for all other activities. Alaka'i is fortunate for this opportunity to appeal to our Hawaii Legislative body through this Grant-in-Aid to help support our goals with a social justice agenda – providing an exceptional educational program that is tuition-free for all our Kauai keiki. Along with providing a cutting-edge education for youths, we want to reach out to families and the community to be a part of the advancement of education. In project-based learning, there are presentations of learning (P.O.L) that not only involve the educational community but families and real-life experts in the process. Family nights of literacy, mathematical, arts, science and other activities will be an extension of learning for our students, but also families and the community.

4. X Describe the target population to be served; and

There are four charter schools on Kauai, but three are Hawaiian/Niihau Language Immersion schools and the other is focused on Hawaiian culture. Alaka'i will be the only charter school on Kauai that will be open to all students throughout the entire island. We will certainly include Hawaiian language and culture that will be integrated throughout our curriculum, but speaking the Hawaiian language will not be a pre-requisite to enroll. Alaka'i is needed to bring this free education to Kauai that will rival private schools, their curriculum and success. In addition,

there are many home-school children that have signed up with Alaka'i with an intent-to-enroll. The home-school population has been a neglected population on Kauai. In a conversation with Superintendent Bill Arakaki, two of our board members asked how many home-schooled families are there on Kauai. Superintendent Arakaki said "lots" and many families do not provide an official reporting of the educational plans for their children. The home-school population is looking for the education of the whole child which Alaka'i will be offering with the integration of social-emotional learning, project-based learning, and individual learning plans.

5. X Describe the geographic coverage.

The school will open at Mount Kahili Park on the south side of Kauai, land which is managed by Knudsen Trustees. With a population of less than 70,000 for the entire island, we will strive to be able to provide busing for the whole island. With Alaka'i opening with 165 students it will help alleviate some of the pressure of over-crowdedness in our other elementary schools and provide an alternative education for the children that learn differently. There is a housing development of 400 homes to be completed by 2018, just 15 miles from the Mount Kahili site. The multi-family homes will be priced in the \$499,000 price range, which is an affordable cost for Kauai, and that means families with children will be their major buyers. The Poipu area is being proposed with additional housing development as well as parts of the west-side of the island, Ele'ele and Kekaha.

II. Service Summary and Outcomes

What are their values, beliefs, and culture so we can connect and support their learning? Diagnostically examining our learners will be a priority.
 - d. Developing Individualized Leaning Plans (ILP) for each child which will entail goal-setting by the student, teacher, and a family member. This practice will ensure that the strengths of each child are acknowledged and growth happens academically, socially, and emotionally.

- e. On-going training in technology and project-based learning will need to be established in the schedules and curriculum-mapping throughout the year.
- f. Responsibilities will be a shared process beginning with the students, teachers, staff, and administration. Alaka'i will be a commitment of change to transform education as it exists today, not so much in content but in the way we teach.
- 2. X Provide a projected annual timeline for accomplishing the results or outcomes of the service;

Month 1-3 (January-March)

- a. A great deal of marketing, public relations and promoting a new way of learning has already been established on Kauai. The model we plan to implement, the iLEAD way, was introduced and shared with the community three years ago. Continued work will happen with town hall meetings, open house, and community sharing at festivals, farmer's markets, and other venues for outreach communications.
- b. The enrollment process has started and is providing an open opportunity for an alternative education and a change in education with the way children learn.
- c. The hiring of our staff will be an important step for the opening of our school. Teachers make the difference and we hope to have dedicated, caring teachers eager to practice the skills of what will be needed for the progressive education that will be emphasized at our school. The Director has been hired and is interviewing candidates that want to learn a new way to teach. The professional development we propose will empower the teachers as leaders as well as learners practicing "The Leader in Me".
- d. Hiring the most qualified technology/data coordinator we can find, will be an important addition to our staff.

Month 4-6 (April-June)

- a. Continue enrolling and informing students, parents and families of the uniqueness of project-based learning, including the arts and self-directed learning.
- b. On June 16, 2018, Alaka'i O Kaua'i Public Charter School will provide an island-wide festival for Kauai An All School International Festival. It will be a fun, educational event with sharing the uniqueness of Hawaii's diverse population. Dancing, food, crafts, art, and a "makery" will be highlighted from selected groups of people: Polynesians, Japanese, Chinese, Koreans, Vietnamese, Portuguese and Hawaiians. We will also use this time to have our future students actively involved in sponsoring this event annually, which will welcome families, and our local community. In addition, the event will be especially entertaining and fun for Kauai's many tourists.

Month 7-9 (July-August- September)

a. Provide a three-week workshop on project-based learning and technology, establishing relationships, and building a community of

learners for our administrator, teachers, and staff. We will want all key stakeholders at the school to experience project-based learning and advance technology, so they each have a deeper understanding of our mission and vision.

b. August 27, 2018, Alaka'i will open their doors and heart to the next generation of leaders for Kauai and the global world.

Month 10-12 (October – December)

Alaka'i is most fortunate in bringing on board a community leader who serve as Treasurer on the governing board who is the Financial and Strategic Manager for Kauai Island Utilities Corporation. He will provide the oversight to ensure the state's money given to Alaka'i school is expended appropriately. The director of the school will be responsible for the reports and is familiar with charter school operations reports for grants. She comes to Alaka'i school with 30 years of operating and managing schools.

Alaka'i will be applying for any Federal grants that may become available for Charter Schools. Alaka'i has plans to apply for Newschools Venture grant that is only for operational school materials and training, not facilities. In addition, a state grant by the Department of Education, "Investing in Innovation Fund – Development Grant" was offered in 2018 and if offered again 2019, Alaka'i will be applying for those funds. In addition, there are foundations, ie. Alexander & Baldwin - Kokua Giving Program that we will also submit proposals for grant funding.

Since we are a new school for Kauai, no state or federal tax credits have been granted, but it is possible the land that we lease will receive property tax allowance for our nonprofit status.

There have been no awards to date from federal, state or county funding other than the Charter School Contract that will provide per pupil funding for our students. The Charter School contract is a five-year contract 2018-2023.

Alaka'i has \$35,000 in its account, but \$32,500 is restricted for the purchase of iPads for students. These have yet to be purchased.

IV. Experience and Capability

1. X Necessary Skills and Experience

Although Alaka'i will be a new school, we have a strong governing board and advisory board to guide us through the services proposed in this application. The most necessary skills and experience for this grant will be the advantage of having a knowledgeable director (past principal with 30 years-experience) operating and managing grants and funding in a charter school. Denise Trentham, the director will bring much needed expertise to the school. In addition, the governing board chair, a higher education (UHM) faulty member and experienced leader has managed National Science Foundation Grants as well as Hawaii Department of Education curriculum grants. DrB Blackwell continues to train and teach at UHM, but also has been working with the iLEAD School Development, which is the school's 501©3 nonprofit organization. The last two years, as Education Consultants with iLEAD, DrB and Ms. Trentham worked as a team to assist in 'proving the model' and now iLEAD Schools Development has opened ten charter schools across the nation. Having the iLEAD model, with 10 year experience to guide and provide the needed training in project-based learning and technology will enhance and advance our school's mission which is to be an outstanding project-based school. The governing board will be direct overseer of this project, but will involve members of the advisory board who are steeped in experience and skills that will be necessary to this request.

2. X Facilities

Alakai's facility is a vacant school at Mount Kahili Park. The school has nine classrooms, a pre-school, a library, health room, office, and a science laboratory. In addition, there is a gymnasium of approximately 33,000 sq ft that could actually house the entire school of 165 students. The Seventh Day Adventist School was the previous tenant for Knudsen Trustees for 29 years. The school and gymnasium was vacated Summer 2012. We are most fortunate to be able to open in this facility and have a five-year contract with option to extend.

V. Personnel: Project Organization and Staffing

1. X Proposed Staffing, Staff Qualifications, Supervision and Training

Providing professional development opportunities and training for the staff will need to be monitored as to the effectiveness and success of the activities.

The Governing Board's Chairperson will be closely involved with the monitoring of this grant. Dr. Kani Blackwell (DrB) – an educator for 51 years and professor of teacher education at University of Hawaii, Manoa (UHM) has the experience and training to provide guidance to the administrator who will directly supervise and implement this grant. Although DrB retired full time from UHM, she continues to teach part-time as an online instructor in the Institute for Teacher Education in the College of Education. DrB was founder of Growing Our Own Teachers on Kauai which has provided financial assistance to 76 Kauai teachers since 2007, with 73 of them still teaching in the Kauai schools or on family sabbatical leave. That is 95% retention rate for teachers remaining in the profession. As an education consultant, DrB discovered that the iLEAD School Development was transforming education and had a ten-year model to follow. With bringing this innovative model to Kauai, DrB led the Alaka'i application governing board to a successful journey to become a public charter school.

Both the governing board and Advisory board members have members are well-trained in financial management of awards.

Advisory Board:

Norma Doctor Sparks - President of Families First Hawaii Services, Inc. on Kauai, is an attorney, and served in the past as Assistant Director/Administrative Deputy in Los Angeles, CA. In her role, she directed the Bureau of Administrative Services that included the Finance, Fiscal, Contracts, Human Resources, and Facilities Divisions. She managed a budget of about \$4 billion and support for about 14,000 staff members. Her ability to work collaboratively and supportive of 14,000 staff members is a project in itself.

Denise Trentham is the Director/Principal of Alaka'i O Kaua'i Public Charter School. She has 30 years of working in public schools including charter schools. Ms. Trentham is excited about the possibility of receiving funds that would allow the new school, Alaka'i to have this immediate and necessary professional development and training. Ms. Trentham is also a strong evaluator and well prepared to supervise the grant and her staff.

Governing Board: Chairperson and Treasurer

DrB has been an evaluator for National Science Foundation grants, Hawaii Department of Education in Mathematics and evaluator for the Technology Grant for the Central Complex Area of Kauai. She has had the responsibility of overseeing budgets and Project Management.

Mr. Rick Eckert is the Financial and strategic Manager for Kauai Island Utility Corporation. Mr. Eckert is quite familiar with government contracts and overseeing finances, reporting financial information, and supervising staff. His experience and knowledge brings a professional level of responsibilities for the island of Kauai.

2. X Organization Chart

The governing board oversees the management of Alaka'i but as of March 15, 2018, the Director/Principal and the leadership team will add to the responsibility and supervision of the staff and employees of Alaka'i as well as for this award. For this request for funding, the director with 30 years of experience in organizational and financial management plus having a professional accountant, who is Financial and Strategic Manager for Kauai Island Utility Corporation, their expertise will add to the supervision and responsibilities of the Grant-in-Aid, if awarded. 
