The Hawaiian Humane Society aims to promote the human-animal bond and the humane treatment of all animals by providing adoptions services, animal care and sterilization procedures, foster care, community outreach and educational programs, and 24-hour animal admissions and emergency response. Founded in 1883, we are the leader in animal welfare issues in Hawaii.

### 2. The goals and objectives related to the request;

Since 1883, the Hawaiian Humane Society has been an integral part of life on Oahu, beginning with the protection of over-worked carriage horses and mules.

Today, the work of the Hawaiian Humane Society includes rescuing over-bred dogs from puppy mills and advocating for legislation to strengthen Hawaii's animal protection laws. The Society's ten humane officers respond to thousands of calls annually to assist animals in neighborhoods across Oahu and are available 24-hours a day, 7-days a week to rescue any animal in need. So much progress has been made as pets have migrated from our backyards into our living rooms and have become full-fledged family members. As human populations in West Oahu communities have grown so has their love of animals. At 61%, West Oahu has the highest percentage of pet owners on the island which has a rate of 55%.

The location of the Moiliili campus does not provide easy access for people living in West Oahu and other areas outside of urban Honolulu. People who need or want services from the Hawaiian Humane Society may currently find it too inconvenient or remote, resulting in animal suffering.

The establishment of a Hawaiian Humane Society campus in West Oahu will provide underserved communities with greatly needed programs and services including animal admissions, adoptions, humane investigations and rescues, lost & found animal care and sheltering, youth education and a community off-leash dog park for the benefit of countless animals and people for generations to come.

### 3. The public purpose and need to be served;

Our more than 130-year history of helping Oahu's people and animals is a testament to how the Hawaiian Humane Society has enriched the community by offering a safe harbor to lost and abandoned pets, encouraging responsible pet ownership, educating our youth, expanding families through pet adoptions, rescuing pets from abuse and neglect and reuniting lost pets and owners across Oahu.

Ninety-five percent of Oahu residents who were polled in 2015 by Honolulu research firm Ward Research believed that animal companionship was imperative to their quality of life. In the last five years, the Hawaiian Humane Society has placed homeless animals with more than 30,000 families. We are not just a bricks and mortar facility—we have played a part in the lives of thousands of families across the island.

Due to projected human and animal population growth in West Oahu, planners Helber, Hastert & Fee projected that by the year 2030, 52% of animals admitted to the Hawaiian Humane Society would be better served by a second campus in West Oahu. As the only animal welfare organization on Oahu that does not turn animals away, the Society recognizes the responsibility to extend our reach to provide vitally needed services in West Oahu.

Some of the programs and services our campus will offer include:

- Animal rescues, animal care and pet adoptions to place pets into loving homes, reunite families with lost pets, rescue lost, abandoned, abused or neglected animals and prevent future animal cruelty.
- Educational initiatives to reach at-risk youth with mentoring and values development programs, provide public education to break the cycle of violence linking animal abuse with family violence, and provide humane education programs for schools and community groups.
- Emergency pet fostering programs to provide care for animals who are too young for adoption, pets of victims fleeing domestic violence, pets of disaster victims and pets of active duty military personnel on deployment.
- Animal transport services to and from the Hawaiian Humane Society's spay/neuter clinic in Moiliili. The clinic provides free or low-fee spay/neuter surgeries for Free-roaming cats and pets of homes and low-income populations to help reduce animal overpopulation and improve the health and well-being of animals.

### 4. Describe the target population to be served;

Meeting spaces, community events and an off-leash dog park to serve as a gathering place and animal resource center for pets and their people. Pet ownership on Oahu has steadily risen over the years.

The Hawaiian Humane Society serves the island of Oahu with a population of 950,000 people. In a recent Ward Research survey, 27% of Oahu residents (approximately 256,000 people) had some form of contact with the Hawaiian Humane Society in the preceding 12-month period. 65% of that contact was an inperson visit to the Moiliili campus.

A second campus in West Oahu would better serve nearly half of Oahu's population of both people and animals. As the majority of Oahu's future growth is forecast to occur in West Oahu, this number will continue to expand.

With just one campus, our animal admissions were more than 25,000 in FY2017. Conservatively, we project servicing approximately 83,000 people a year and nearly 14,000 animals at our planned West Oahu campus. Based on the research of mainland animal welfare organizations who have added a second campus, these projections are likely to be surpassed once our doors have opened.

### 5. Describe the geographic coverage.

The West Oahu campus will provide more convenient access to Hawaiian Humane Society programs and services for the growing population who reside west of Aloha Stadium.

The construction of a Hawaiian Humane Society campus in West Oahu will provide greatly needed programs and services for underserved communities including animal admissions, adoptions, humane investigations and rescues, pet lost & found, animal care and sheltering, youth education and a community offleash dog park.

A grant of \$1,000,000 will help underwrite Phase One of the West Oahu Campus construction providing the infrastructure necessary to proceed with this important

project. Phase One includes costs for site work include grading, drainage and backfill, site access/ingress and egress and additional work necessary to comply with building codes.

2. Provide a projected annual timeline for accomplishing the results or outcomes of the service;

The planning for this project is well underway. Site work on the campus will begin September 2018 and take approximately four months to complete. The Society anticipates opening the West Oahu campus to the public in January 2020.

3. Describe its quality assurance and evaluation plans for the request. Specify how the applicant plans to monitor, evaluate, and improve their results; and

The success of our project will be defined by a timely completion within the outlined budget. Hawaiian Humane Society President & CEO, Lisa Fowler, and Board Chair, Robert Armstrong, will continue to work with the Board of Directors and project contractor to ensure that construction is moving forward as planned. While our goal is an ambitious one, we are confident that we will achieve our objectives.

Once the West Oahu campus is open to the public, the programs and services will be evaluated for impact and effectiveness by gathering feedback from the public. The Hawaiian Humane Society has commissioned surveys of community members every three years since 1993 to help ensure that we are providing the highest quality service for the community's animals and people and addressing our community's most critical animal welfare issues. The Society's most recent survey conducted in 2015 indicated that 87% of residents who had contact with our organization reported that contact to be positive.

The Society also maintains monthly statistics on all animal admissions and adoptions and will perform ongoing analysis of the operations of both of our campuses to ensure that we are maximizing opportunities to provide services across the island.

The Hawaiian Humane Society has been Oahu's leader in animal welfare issues for more than 130 years. In fiscal year 2017, we provided shelter and care for 25,165 animals, found new families for 7,838 homeless pets, performed 7,299 spay/neuter surgeries, provided humane education to 30,146 youth across Oahu and worked with 9,677 community volunteers.

In order to better serve Hawaii's animals and people, the Society recently completed renovations and an expansion to our existing campus in Moiliili. The project included the construction of a new veterinary clinic and admissions center, two new dog adoption pavilions and a new cat adoption building. These new buildings were designed to optimize the behavioral, psychological and socialization needs of the animals, ease of cleaning and maintenance, enhance disease control and improve the overall experience for animals and the people who visit them. The project was completed on time and on budget.

Similarly, our West Oahu campus is being designed to reduce stress on the animals, promote positive behaviors and provide the best experience for visitors. The successful completion of construction to our existing campus combined with our long-standing history of providing programs and services in our community gives us the confidence that our second campus in West Oahu will provide a significant benefit for animals and people.

#### B. Facilities

In 2015, a five-acre parcel on Fort Weaver Road was donated by D.R. Horton to the Society and planning for the campus began. - Robert Armstrong is President of Armstrong Companies and CEO of Armstrong Builders, LLC. Mr. Armstrong has served on the Hawaiian Humane Society Board since 2012 and is finishing his first year as Board Chair. Mr. Armstrong has been a leader in the construction industry in Hawaii for more than 35 years. He has held multiple positions in the National Association of Home Builders and the Building Industry Association. He has extensive experience in building residential homes, affordable housing communities and commercial projects.

## DECLARATION STATEMENT OF APPLICANTS FOR GRANTS PURSUANT TO CHAPTER 42F, HAWAI'I REVISED STATUTES


The undersigned authorized representative of the applicant certifies the following:

- 1) The applicant meets and will comply with all of the following standards for the award of grants pursuant to Section 42F-103, Hawai'i Revised Statutes:
  - a) Is licensed or accredited, in accordance with federal, state, or county statutes, rules, or ordinances, to conduct the activities or provide the services for which a grant is awarded;
  - b) Complies with all applicable federal and state laws prohibiting discrimination against any person on the basis of race, color, national origin, religion, creed, sex, age, sexual orientation, or disability;
  - c) Agrees not to use state funds for entertainment or lobbying activities; and
  - d) Allows the state agency to which funds for the grant were appropriated for expenditure, legislative committees and their staff, and the auditor full access to their records, reports, files, and other related documents and information for purposes of monitoring, measuring the effectiveness, and ensuring the proper expenditure of the grant.
- 2) If the applicant is an organization, the applicant meets the following requirements pursuant to Section 42F-103, Hawai'i Revised Statutes:
