Hawaiian Kamali'i, Inc. dba Hawaiian Canoe Club (HCC) has a mission to perpetuate and preserve the art of Hawaiian canoe paddling by providing an environment rooted in traditional Hawaiian values that promote personal growth, character development, and achievement in physical fitness.

Founded in 1960, Hawaiian Canoe Club has emerged as a transformative leader because of our ability to balance competitive paddling with the values, traditions and lessons of Native Hawaiian culture. HCC has provided a cultural and educational program to about 90 children every summer since 1992. Competitively, HCC has held the Maui County Championship title since 1985 and has won the Hawaiian Canoe Racing State Championship 14 out of the last 17 years.

2. The goals and objectives related to the request;

Hawaiian Canoe Club seeks support for capital improvements to the Club Hale at Hoaloha Park in Kahului. Our goal is to improve safety and security of club facilities. The primary objective related to this request is to replace chain-link gates with lightweight, prefabricated metal gates. The new gates will provide long-term security and will withstand exposure to salt, humidity and wind.

3. ☐ The public purpose and need to be served;

Hawaiian Canoe Club serves this community as one of the very few child-centered facilities with access to the ocean on the north shore of Maui. The club site provides a safe place for children and families to spend time and grow through rich experiences.

Through the summer cultural and educational program, HCC offers opportunities for children as young as ten to experience open ocean paddling to neighbor islands, work in lo'i kalo, study Native Hawaiian language, history and culture, and hike to remote areas of Maui Nui. Youth leaders complete certification trainings in CPR, first aid and water safety / lifeguarding. Upon completion of the training, about ten teens are selected each summer to serve as mentors and receive a work stipend for their service.

HCC supports year-round activities for Maui youth and is highly involved with the Maui Interscholastic League (MIL) padding program. HCC members volunteer as coaches and officials and we host Seabury Hall and King Kekaulike High School paddling teams at our club site. The Club Hale also supports a growing recreational paddling program involving more than 70 people, primarily seniors over 55 years of age. They paddle, organize beach clean ups, practice hula and oli, and gather for breakfast potlucks. HCC is developing wellness, weight training and nutrition programs to better support this growing group of kūpuna members.

4. ☐ Describe the target population to be served; and

Since its founding in 1960, HCC has been dedicated to nurturing and supporting the youth of Maui. With the rise in popularity of ocean sports, paddling attracts at-risk youth who may not identify with traditional sports teams or educational programs. Using "sports as a hook" to engage young people, paddling opens the door to learning about culture, history, navigation techniques and the environment. Through years of involvement, our kids learn to see themselves as lifelong learners, disciplined athletes and stewards of the environment.

HCC is comprised of 300 members, out of which about 150 are keiki paddlers. The summer cultural and educational program serves up to 90 children, ages 10 to 14, and 10 youth leaders, ages 14 to 18. For many children, HCC provides tremendous opportunities they will not get otherwise. Over years of involvement, children from single parent- and low-income-households, poor grade performance and other risk factors thrive as they develop confidence and a sense of kūleana (responsibility). We also serve a growing kūpuna membership through paddling, cultural programs and social activities for older adults.

HCC operates on a .75 acre parcel at Hoaloha Park on Kahului Harbor on the north shore of Maui. This central location is accessible to students from various schools in the Baldwin – Kekaulike – Maui Complex Area. Our site is a drop-off location for the Maui Economic Opportunity bus program, so youth from central and upcountry schools can ride the bus to practices and activities.

The HCC Board of Directors recently negotiated a fifty-year lease with the County of Maui. HCC seeks to invest in this vital public space for our community and future generations of paddlers.

II. Service Summary and Outcomes

The scope of work involves replacing existing chain link gates surrounding the ground level of the Club Hale with durable pre-fabricated security gates. The ground level is about 2,775 square feet with a kitchen and meeting area, storage for one-man and two-man canoes, and storage for two wa'a koa (koa canoes). The new gate system includes fourteen panels (8'4" x 8'). The panels will be hinged to enable double swing gates with locking latch systems. Originally installed in 1997, the existing chain link gates have eroded due to constant exposure to the salt air. With a life expectancy of fifty years, the improved gate system will greatly enhance safety and security of this facility.

The Board President has prepared plans and estimates for the planned improvements and will lead the project. He will oversee work by a construction vendor, which will be selected by competitive bid process, with final approval by the Board of Directors. The Club Manager will oversee logistics, manage financial payments and record keeping, organize volunteer support and will be responsible for reports to funders.

Hawaiian Canoe Club (HCC) was founded in 1960 by John M. Lake, a police lieutenant and renowned community leader. The twenty-five charter members wanted to expose Maui keiki to cultural practices and values through outrigger canoe paddling. Hawaiian Kamali'i, Inc., an autonomous 501(c) 3, was created in 1992 to focus on youth development and cultural preservation in the setting of competitive racing.

The existing Club Hale was constructed in 1997, establishing a permanent structure to support cultural and educational programs as well as competitive paddling at HCC. In 2009, the organization raised \$150,000 in private funds for sustainability upgrades to the facility. This involved the construction of a second floor and sustainability upgrades, a photovoltaic system, an energy-efficient air conditioning system, insulation, and six skylights. In 2011, HCC constructed a traditional hale to support cultural programs. The traditional hale was built by master hale builder Francis Palani Sinenci of Hāna and our members who contributed more than 1,500 hours of volunteer labor.

Since 2013, HCC has held contracts of up to \$25,000 annually with the Hawaii Tourism Authority in support of the Maui Jim Pailolo Challenge. This is a 26-mile canoe race from D.T. Fleming Beach on Maui to Kaunakakai Pier on Moloka'i. The Pailolo Challenge is an internationally renowned event, attracting canoe paddlers from around the world. We typically host 85-90 crews from all Hawaiian Islands, California, Oregon and visiting countries such as Canada, Australia, American Samoa and China.

The HCC Club Hale occupies a .75 acre parcel that is leased from the County of Maui. The main hale is a 2,775 square foot structure built in 1997 and retrofitted for energy savings in 2009. The first floor has a large open meeting/gathering area, canoe storage racks, a kitchen, a weight room, and recently renovated ADA-compliant restrooms. The second floor has a classroom, a boardroom with bathroom, and an office.

Also on the park is our traditional hale, which is a gathering place to perpetuate, preserve, and celebrate traditional Hawaiian practices. In 2011, this site was designated by Maui County as a Cultural Historical Site.

The HCC staff is led by Club Manager, Kaili Moikeha This individual is responsible for administering all youth programs, coordinating use of the facility and equipment, financial management, and human resources. She oversees data collection as well as program evaluation, assessment, finances and reporting. In addition to her position with HCC, Kaili is the Hawaiian Canoe Racing Association Area Coordinator and works as a Safety Consultant with Hawaii Risk Evaluation Service.

The Program Director, Paul Kauhane Lu'uwai, is responsible for supervising and training the summer educational and cultural program. The Program Director works closely with the Club Manager to coordinate year-round activities. Paul has served for more 30 years as Program Director and Head Coach of the Keiki Division at HCC. Paul holds a Master's Degree in Education with emphasis in Curriculum Development from the University of Hawai'i.

Dave Ward, the HCC Board President, will oversee the proposed project. Dave is the founder and principal of Frampton & Ward, LLC, a real estate development and project management firm. Dave has led the HCC board for over 10 years and has overseen three major projects at the club site.


- 1) The applicant meets and will comply with all of the following standards for the award of grants pursuant to Section 42F-103. Hawai'i Revised Statutes:
 - a) Is licensed or accredited, in accordance with federal, state, or county statutes, rules, or ordinances, to conduct the activities or provide the services for which a grant is awarded;
 - b) Complies with all applicable federal and state laws prohibiting discrimination against any person on the basis of race, color, national origin, religion, creed, sex, age, sexual orientation, or disability;
 - c) Agrees not to use state funds for entertainment or lobbying activities; and
 - d) Allows the state agency to which funds for the grant were appropriated for expenditure, legislative committees and their staff, and the auditor full access to their records, reports, files, and other related documents and information for purposes of monitoring, measuring the effectiveness, and ensuring the proper expenditure of the grant.
- 2) If the applicant is an organization, the applicant meets the following requirements pursuant to Section 42F-103, Hawai'i Revised Statutes:
 - a) Is incorporated under the laws of the State; and
 - b) Has bylaws or policies that describe the manner in which the activities or services for which a grant is awarded shall be conducted or provided.
- 3) If the applicant is a non-profit organization, it meets the following requirements pursuant to Section 42F-103, Hawai'i Revised Statutes:
 - a) Is determined and designated to be a non-profit organization by the Internal Revenue Service; and
 - b) Has a governing board whose members have no material conflict of interest and serve without compensation.

Pursuant to Section 42F-103, Hawai'i Revised Statutes, for grants used for the acquisition of land, when the organization discontinues the activities or services on the land acquired for which the grant was awarded and disposes of the land in fee simple or by lease, the organization shall negotiate with the expending agency for a lump sum or installment repayment to the State of the amount of the grant used for the acquisition of the land.



Hawaiian Canoe Club Organizational Chart








