APPLICATION FOR GRANTS

I. Background and Summary

Music & Arts Training Center of Hawaii is a 501 (C) 3 organization established to:

- a. Become an education center where people of all ages, communities and abilities can discover, develop and nurture their creativity in music and the arts;
- Provide an opportunity for people from all walks of life including the less fortunate, homeless families, disadvantaged and "at-risk" youth reach their full potential and use their gifts and talents bless their communities;
- Collaborate with community and civic organizations including churches provide opportunities and enable our students pursue their passions and become part of the labor force and the business sector;
- d. Work with other community and civic organizations including churches to help with feeding the homeless, stream and beach cleanup as well as graffiti cleanup.
- e. Visit the elderly and the disabled who are either confined in care homes, nursing homes and other facilities, by bringing to them entertainment and pleasure in music and the arts.

2. The goals and objectives related to the request

Since opening its doors in early 2013, we have come across kids and adults who have the desire and passion for music and the arts, however, they do not have the resources. In other words, they need help financially, hence we established a scholarship program, wherein those who do not have the means can avail themselves of this opportunity. We currently have students we cannot charge tuition fee because they just do not have the means, and we cannot admit too many because of our limited resources as well.

With this funding, we would like to accomplish the following:

- Scholarship program to enable those who have the desire and passion for music and the arts but do not have the resources;
- b. We would like to secure our own studio, so a portion of the grant request will be used to cover the increase in rent. Currently, we are sharing a room with a ballet school on a limited basis. We would also like to offer other classes

- including piano, guitar, drums and other disciplines that people are mostly interested in;
- Supplement the compensation for our instructors who are currently not receiving any regular compensation except for about \$200 each month to reimburse their expenses;
- d. Marketing and advertising costs in order to grow the school and consequently, increase our support base which will eventually supplement the tuition fees collected from paying students in order to continue operations.

3. The public purpose and need to be served

Currently, we have 2 group classes on Wednesdays, one class for the children and another class for adults in the Kalihi area. We would also like to open 2 additional group classes in the Waipahu area, one for the children and another class for adults. With this funding, MATCH will be able to extend help to others who are waiting to receive scholarships.

Since the Center would also like to reach out to the elderly and the disabled confined in care homes, nursing homes and other facilities to provide entertainment and delight to them, if we have more people that we can train, then we would be able to visit more of these facilities on a regular basis. Hence, the need is there, so this grant request is such a vital component of our mission in order for us to reach our goals and objectives as well as expand our reach.

4. Describe the target population to be served

As stated in item (3) above, our target population are both children and adults who have the passion for music and the arts including homeless families and children, the disadvantaged and "at-risk" youth. In turn, our students would then be encouraged to join teams to visit care homes, nursing homes and other facilities where the elderly and the disabled are confined to provide entertainment and delight.

5. Describe the geographic coverage

Our geographic coverage is confined to the Honolulu area although we do have students from Waipahu and Mililani as well as the Windward side, so as the Center grows, we plan to expand our coverage to areas outside of Honolulu.

As soon as we receive the grant, within 30 days from receiving funding, we plan to open additional classes to accommodate students who have been on the waiting list. We also plan to talk to agencies who are currently servicing homeless children and adults and see how we can start working with them. We should be able to accomplish our goal of forming 6 more group classes in 6-9 months. Then, in about another 6 months, we should be able to get our new students involved in visiting care homes, nursing homes and other facilities where we can bring entertainment and delight in music and the arts to the elderly and the disabled.

We have developed an evaluation form that will be provided to the parents of the children and the adult students to give us feedback on how they are benefitting from the classes being provided to them and also give everyone the opportunity to give suggestions or ideas on how to improve the services being provided.

We will also provide the same evaluation form to administrators, operators and/or managers of the facilities that we visit or provide services to, to enable them to provide us with their feedback on the services provided. We have also been using a room at no charge at Light of the World Ministries in Mapunapuna to hold our classes for the past 12 months.

We anticipate our students to triple or quadruple in size over the next 9-12 months, which might require us to hire a part-time administrative assistant to help our current Administrator volunteer currently taking care of our administrative and management needs.
