## Improving Youth Sexual Health by Empowering Parents to Take Responsibility for Educating Their Children

## I Background and Summary:

#### 1. Applicant's Background

**PEACE Global** is a 501c3 dedicated to *parents* and their leadership role in the educational needs of children, particularly in sex education.

**PEACE** leadership has become certified in the *sexual risk avoidance strategy*. The *risk-avoidance model* is effectively used by public health to address health concerns such as smoking, and drug use and does work well to reduce teen sexual activity, thus reducing pregnancy and sexually transmitted infections. These lifestyle choices contribute to the youths short and long term physical, mental & emotional well being, their ability to complete school, and their earning potential.

To this end PEACE has become certified as sexual risk avoidance specialists, and in two SRA programs:

- 1) **Building Family Connections** An 8 hour training that empowers *parenting* to begin the life-long conversation about Sex and Healthy Relationships with their children & youth.
- 2) Heritage Keepers Abstinence Education is a classroom-based curriculum that teaches students the benefits of practicing sexual abstinence and the risks that can be associated with sexual activity outside of marriage.

Below are detailed program descriptions taken from the related websites.

#### Youth Program - Heritage Keepers

The goal of the Heritage Keepers® Abstinence Education program is to reduce the number of teens initiating sexual activity and increase the number of sexually active teens returning to abstinence. The Heritage program uses theoretical models and various methodologies in program implementation and The Heritage Keepers® Abstinence Education program encourages teens to:

- o develop a strong sense of personal identity and worth,
- o set protective boundaries,
- o resist negative peer pressure,
- o determine and protect personal values and goals, and
- o set high standards for themselves.

A significant amount of the curriculum focuses on reproduction and sexually transmitted diseases (STDs), specifically discussing STD symptoms, treatments/cures, and prevention (all with information provided by the Office of Adolescent Pregnancy Prevention and approved for medical accuracy). Condom efficacy is also explained in relation to each STD.

Heritage Keepers® educators are trained to address the varying levels of sexual experience among teens including sensitivity to those who may have been sexually assaulted or abused. This holistic curriculum has received overwhelmingly positive feedback from students who have gone through the course, with post program interviews indicating that more than 90% of participating students strongly liked the program and instructor and would recommend it to a friend.

The Heritage Keepers® curriculum has been approved by the Medical Institute for Sexual Health and the US Department of Health and Human Services, Office of Population Affairs, for medical accuracy and scientific referencing. Heritage ensures that the curriculum is research-based with over 80 references from widely accepted social science research to support curriculum information. The Heritage Keepers® curricula is on the Department of Health and Human Services List of Approved Teen Pregnancy Prevention Programs. It is also approved for adherence to federal A-H legislative requirements for abstinence education as set forth in Section 510(b) of Title V of the Social Security Act. The Heritage Keepers® program also meets all 66 standards of the CDC-funded SMARTool (Systematic Method for Assessing Risk-avoidance Tool).

Heritage Keepers® has been tested and found to reduce teen sexual activity by 67%.

#### Parent Program - Building Family Connections -

An 8 hour training that empowers parenting to begin the life-long conversation about Sex and Healthy Relationships with their children & youth. The Building Family Connections (BFC) curriculum is an interactive sexual health curriculum. It teaches content on sexual health, skill-building on parent-child connectedness and communication. The BFC curriculum was developed in association with a grant from the Centers for Disease

Control and Prevention (CDC) and is provided by the Medical Institute.

#### Why is it important?

Effective **parent-child** communication makes healthy adolescents! Since **parents** are the most influential factors in an adolescent's sexual decision making, it is essential that **parents** talk to their children before their peers or the media does. Increasing **parent-child** communication on the sensitive topic of sexual health can

lead to a delay in sexual activity in adolescents. However, **parents** are hesitant to talk to their children about sex or do not know how to do so. The curriculum provides information on how parents can communicate effectively with their children on sexual health issues.

#### 2. Goals and Objectives Related to the Request

The stated goals of the programs are:

- · Increasing the age of sexual debut
- · Decreasing the number of sexual partners
- Decreasing non-marital childbearing and resulting single-parent homes
- Decreasing sexually transmitted diseases and associated infertility issues
- Increasing the number of individuals who have the skills necessary to form healthy relationships, build strong marriages and form safe and stable families
- · Increase parent child connectedness
- · Increasing awareness of family structure
- · Increasing the value of marriage and committed love
- Increasing awareness regarding poverty as a determinate of health
- Decrease poverty and increase self-sufficiency through proven science based strategies

Currently we have 4 Heritage Keepers® instructors and 1 Building Family Connections instructor. Our

Our goal is to expand our services by training 25 more facilitators in the fall of 2018.

#### 3. Public Purpose and Need

Teen pregnancy and sexually transmitted infections (STIs) are serious public health issues. Hawaii's STI epidemic is most severe among young people, especially young women. For example, Hawaii has the 12th worst chlamydia rate and the 10th highest teen pregnancy rate in the nation.

#### 4. Target Audience

- a) Parenting adults This would include parents, grandparents who are raising children, or any other authority involved in a child's life
- b) Youth in Grades 6 to 12.

Source Locations: churches, schools, home school networks, community centres with youth programs

#### 5. Geographic Coverage:

We have had interest and activity on Oahu, Molokai, Kauai, and Maui. Once organized we believe there is need on all islands throughout the state.


