I. Background and Summary

- 1. Glen Tomlinson, a UH graduate in Travel Industry Management, has over 40 years experience in the Hospitality Industry. Janet Tomlinson has over 40 years experience in the Hospitality Industry as well. In 1991, the Tomlinsons created an exclusive WWII military base tour program and museum called the Home of the Brave. As the official repository for the Pearl Harbor Survivors Association, the museum houses the largest private WWII collection in the Pacific.
- 2. The grant request is to sustain and maintain the museum collection while educating the public on the historic value and role that Hawaii played during WWII. We plan on implementing new technology into the exhibits to entice a younger generation to learn and experience the important lessons of WWII. This advancement in disseminating information in a more entertaining and modern way will also generate exposure and interest to Hawaii's historical sites world-wide through social media and apps that will be created.

The Home of the Brave Museum serves as the steward and repository of historical artifacts and memorabilia pertaining to the United States military. Highlighting the heroic service of our 100 BTN, 442 RCT, & MIS, we proudly share the legacy of our local Nisei soldiers. We believe education of wartime history brings about communion and unity between peoples and nations, therefore we provide a unique learning platform to engage and educate our diverse local community on an important piece of Hawaii's history as well as honor the memory of our veterans and their families. In addition to our expansive WWII collection, we provide a forum for veterans and their families to share their stories to bridge international & intergenerational gaps. Our purpose for this request is to maintain this historic Kakaako museum to further promote awareness, gratitude, and documentation of Hawaii's military heritage for public interest and educational purposes with the latest technology.

- 3. Over 100,000 WWII Veterans have visited the Home of the Brave museum and have shared their stories and donated their treasured artifacts, showcasing the war in the Pacific as well as the European theater. Our WWII veterans are passing away and there is a strong need to preserve their legacy for our present and future generations in a relevant way for all ages.
- 4. Our target population served is all age groups. Both local and visitors from around the world have enjoyed learning from the educational and hands-on history that is showcased in the museum. We also support educational institutions, military (retired & active duty), hospitality industry travel agencies, hotels, cruise ships, etc.
- 5. Geographic coverage is global. While our main focus is to serve the people of Hawaii, we have worked with many international companies hosting guests from around the world. Home of the Brave has collaborated with the National Geographic Society, History & Discovery Channels for programming that has highlighted Hawaii and has been globally broadcasted.

II. Service Summary and Outcomes

1. The Home of the Brave Museum has been called the "Keeper of the Flame" for thousands of WWII Veterans and their families who wish to showcase the service and sacrifice of our "Greatest Generation". We feel responsible to share this important part of Hawaiian &

American history in which Hawaii played such an important role. Through our educational and experiential hands-on historical exhibits (to be upgraded with this grant), the Home of the Brave museum is able to pass on the lessons learned from a world at war. In todays ever emerging tech world, we are bridging the multi-generational gap, teaching history in a more "fun" and entertaining venue for our youth with technology. iPads (museum kiosks) along with an app for iOS and android phones will be utilized to share the stories and collection with visiting guests. This will also allow visitors and any interested parties to experience the Home of the Brave museum while on-site as well as away from the museum. Schools and other educational institutions will be able to utilize this app for teaching purposes. WWII telephone receivers with audio historical narrative will explain the collection and background stories of what our visitors are looking at.

- 2. The Home of the Brave museum is presently operational and open to the public. Our goal is to increase our visitor count through numerous educational programs and marketing. Our future goal is to relocate to a larger facility to expand the museum with an educational center and parking for school, tour buses, local and visiting guests.
- 3. The Tomlinson family has a stellar track record in creating and maintaining quality service in the Hospitality Industry. Monitored by numerous on-line and social media venues along with accolades from the Honolulu City & County, Hawaii State, Military Commands, educational institutions, world-wide press, our operation is constantly reviewed and overseen internally and externally. As Executive Director, Glen Tomlinson oversee's all aspects of the business and navigates the course of business to improve effectiveness in all areas. Corrective action will be taken immediately for any identified problems and the budget will be carefully reviewed on a regular basis.
- 4. Reporting the effectiveness of the Home of the Brave museum's mission to the State agency will be reflected in the increase of guests served and technological advances in our educational programming. We plan on building a more interactive and enjoyable way of learning for our younger generation who are growing up with ever-changing technology. Museum record keeping includes documenting the monthly guest count to the museum. Public & community outreach will also be tracked through social media, app signups, and website traffic. A quarterly newsletter will be created to send out to all interested parties with interactive input from participating followers.

The measures of effectiveness will include:

- 1) Increasing museum attendance through marketing online, print, and media exposure. Expansion of local, visitor (domestic & foreign), & military guests.
- 2) Improve artifact displays with improved lighting and interpretive hands-on learning and story telling. Development of multi-lingual educational museum tours.
- 3) Technology upgrades to enhance guest interest and increase audience reach through a developed app.

IV. Experience and Capability

1. Necessary Skills and Experience: Over 40 years of business experience in the Hospitality Industry, along with military contracting. Janet & Glen Tomlinson created the first and only military base tour program in the history of the State of Hawaii and designed and hand-built the Home of the Brave Museum. Extensive knowledge in Hawaii business practices, contracting, and permitting. Awarded certificates of appreciation and commendations from the City & County of Honolulu and the State of Hawaii for numerous contributions to Hawaii's veterans and the education of our local public & island visitors. Recognized by military top commanders for the preservation of military history for retired and active duty personnel.

2. Facilities: The museum is located in historic Kakaako at 909 Waimanu St. We have been tenants since 1992. The building was built in 1927. Home of the Brave has put thousands of dollars in improvements over the years to upgrade the building.

V. Personnel: Project Organization and Staffing

1. Proposed Staffing, Staff Qualifications, Supervision and Training: The museum is presently staffed by the Executive Director, Glen Tomlinson and the Director Janet Tomlinson. With the additional educational programing we are pursuing, a historian educator will be added. Our lead historian guide who previously operated and managed our military base tour programs will be re-hired for operational and educational responsibilities. Olav Holst is a retired US Army Major who has over 18 years of service with Home of the Brave and is well known on-island and nationally as a knowledgeable WWII historian.

Accounting and book keeping (listed under professional services) will be done by Julie Wassel who has over 15 years employment with Home of the Brave. Julie has additional experience with other non-profit institutions in Hawaii.

- 2. Organizational Chart: Daily operation and management of the museum is performed by the Executive Director Glen Tomlinson & Director Janet Tomlinson. Historian educator Olav Holst will be supervised by the Executive Director and is responsible for operational duties and educating visiting guests.
- 3. The Executive Director, Glen Tomlinson and Director, Janet Tomlinson built the museum, acquired the collection, and created the Remember Honor Salute foundation. They maintain the daily operations, marketing, educational programming, and maintenance of the facility and will be paid a yearly salary of \$36,000 each. The historian educator will be paid \$22,000. Payroll taxes and assessments along with medical benefits are included in the budget categories.

VI. Other

- 1. Litigation: No litigation or judgements are pending
- 2. Applicant was a director in the DOD WWII Commemoration Committee from 1991 to 1995. Presently active in the DOD Vietnam Commemoration Committee.
- 3. The grant will not be used to support or benefit a sectarian air non-sectarian private educational institution.
- 4. Future Sustainability: A combination of revenue streams fundraising activities (public & corporate), endowment from future grants, museum entree fees, and partnering with outside tour operators will aid in the sustainability of the museum. The foundation is pursuing other federal and corporate grants/funding as well. The technological upgrades implemented with funding from this grant will create additional operational efficiencies and public interest and will contribute to supporting the on-going funding needed to sustain the museum.

In the future, we hope to relocate to a larger facility with additional visitor parking (school buses & tour buses). Our collection continues to expand and we will need additional space for artifacts and educational study.

I am writing in strong support of the Tomlinson family's application for State Grant-in-Aid funds for the *Home of the Brave Museum*'s operations in Kakaako in FY 2019.

The Home of the Brave Museum was founded in 1995 by Glen and Janet Tomlinson as part of their Home of the Brave Tours, which were widely-regarded as the most exclusive World War II military base tour in the world. Through its start as a collection of donated World War II artifacts, the Home of the Brave Museum has developed a highly unique approach towards honoring World War II veterans' sacrifices through preservation of their individual stories and memorabilia.

As the largest private collection of World War II memorabilia and artifacts in the Pacific, this "living museum" offers attendees an opportunity to experience one-of-a-kind displays of authentic World War II artifacts and to interact directly with its displays. For example, visitors can board a World War II Jeep or a 1942 Army-issue Harley-Davidson motorcycle, take photos in the midst of displays honoring their parents' generation, or relax in a camouflaged-lanai setting that is reminiscent of the bunkers that World War II veterans occupied during the war.

The December 7, 1941 attack on Pearl Harbor and Hawaii residents' experiences throughout World War II captured an incredible chapter in America's history. With thousands of Hawaii's young men of Japanese-American ancestry volunteering to serve in the 100th Battalion and in the 442 Regimental Combat Team, and Hawaii's Japanese-American residents experiencing vastly different treatment from others in mainland states, Hawaii's World War II experiences demonstrate how a group of brave individuals could change the course of history through their sacrifices.

With its *Home of the Brave Museum* memorabilia, the Tomlinson family's commitment to preserving the uniforms, equipment, memorabilia and historical records of these turbulent times carries an air of authenticity that is unmatched by other World War II

visitor destinations. On December 4th, 2016, the Tomlinsons hosted the *Home of the Brave 75th Anniversary* Block Party to remember, honor, and salute World War II veterans and their families, and commemorated the 75th anniversary of the bombing of Pearl Harbor. The event also recognized members of the 442nd Regimental Combat Team, 100th Battalion, and the Military Intelligence Service.

What is especially memorable about the *Home of the Brave Museum* is its local feel in central Kakaako, where the museum exhibits and displays, along with its microbrewery, recreate the culture of the 1940s via the World War II memorabilia and vintage music and movie posters featured throughout the brewery's dining hall.
