A public hearing of the Kalaeloa members of the Hawaii Community Development Authority ("Authority" or "HCDA"), a body corporate and a public instrumentality of the State of Hawaii, was called to order by John Whalen, Chairperson of the Authority at 12:00 p.m. on Wednesday, July 11, 2018 at 547 Queen Street, 2<sup>nd</sup> Floor Conference Room, Honolulu Hawaii 96813.

# DEVELOPMENT PERMIT APPLICATION No. KAL 18-005: RP Makai Owner, LLC Project

Chairperson Whalen introduced the representatives for the Applicant. He followed by stating that the public hearing was for Development Permit No. KAL 18-005 and that it was being held in accordance with Hawaii Revised Statutes Section 206E-5.6, Hawaii Administrative Rules ("HAR") Chapter 15-219 and HAR Chapter 15-215.

The Applicant is requesting a development permit to upgrade and expand existing recreational amenities for use by three existing RP Makai Owner, LLC residential projects. The proposed recreational amenities include: (1) two swimming pools with related facilities, including lounge chairs, a barbeque area, and fencing with gated entries; (2) a covered picnic table area; (3) an open pavilion shelter, (4) replace an existing dog park, including a dog wash area; (5) landscaping with irrigation; and (6) expand an existing parking lot. The Project also proposes a new bicycle parking area.

## **LEGAL NOTICE:**

Chairperson Whalen stated that the Application date is May 3, 2018. A public hearing notice was published in the Honolulu Star-Advertiser, The Garden Island, West Hawaii Today, Hawaii Tribune-Herald and Maui News on June 1, 2018.

## **PROCEDURES FOR HEARING:**

Chairperson Whalen explained the procedure for the public hearing. The HCDA staff presented a report summarizing the development permit application, including a description of the Project. The Authority members were given the opportunity to ask questions of HCDA staff.

This was followed by Applicant's Representative's request that the Authority enter into record Exhibits A, B, C, D, E, F, G, H, I, J, K, L, M, and N.

Subsequently, the Applicant's Representative designated and established qualifications of the expert witnesses for examination by the Authority members. The list of expert witnesses was entered into the record.

The Applicant's Representative proceeded with the presentation of the Project, followed by questions from the Authority members.

Chairperson Whalen proceeded with the public testimony. There was one person who offered oral testimony in support of the Project.

### **ADJOURNMENT:**

Chairperson Whalen closed the public hearing at 1:08 p.m.
