BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTI	ON 1. Section 235-16.5, Hawaii Revised Statutes, is
2	amended by	amending subsection (e) to read as follows:
3	" (e)	The department of health shall:
4	(1)	Certify all qualified cesspools for the purposes of
5		this section[; provided that, as a pilot program, the
. 6		department of health, in its discretion, may certify
7		no-more than two-residential large capacity-cesspools
8		as qualified cesspools];
9	(2)	Collect and maintain a record of all qualified
10		expenses certified by an appropriate government agency
11		for the taxable year; and
12	(3)	Certify to each taxpayer the amount of credit the
13		taxpayer may claim; provided that if, in any year, the
14		annual amount of certified credits reaches \$5,000,000
15		in the aggregate, the department of health shall
16		immediately discontinue certifying credits and notify
17		the department of taxation.
