Dear President Kouchi, Speaker Saiki, and Members of the Legislature:

Re: SB2027 SD2 HD1 CD1

SB2027 SD2 HD1 CD1, entitled "A BILL FOR AN ACT RELATING TO APPROPRIATIONS TO ADDRESS HOMELESSNESS" will become law without my signature, pursuant to Section 16 of Article III of the State Constitution.

The purpose of this bill is to appropriate \$1.5 million for fiscal year 2018-2019 to the Department of Human Services to continue and to improve the coordinated statewide homeless initiative to prevent homelessness and re-house homeless people in the state.

This bill authorizes the Department of Human Services to contract the services of a master contractor to procure and oversee subcontracts for the coordinated statewide homeless initiative. The master contractor will operate a coalition of agencies to provide: (1) homeless diversion services by providing short-term financial assistance to households in the eviction process; and (2) housing navigation services and placement of homeless households into permanent housing.

Homelessness continues to be a major issue in Hawai'i and requires resources and the coordinated efforts of all levels of government and the private sector to ameliorate. However, we are concerned about the statutory requirement that the entire

amount of \$1.5 million be provided upfront to the master contractor. The provision of all appropriated public funds in advance to a private entity is not aligned to standard procurement processes consistent with the goals of public accountability and public procurement practices. This mandate severely limits DHS's ability to carry out its fiduciary duty to manage and oversee taxpayer funds as required by this bill.

For the foregoing reasons, SB2027 SD2 HD1 CD1 will become law as ACT 219, Session Laws of Hawai'i 2018, effective July 10, 2018, without my signature.

A BILL FOR AN ACT

RELATING TO APPROPRIATIONS TO ADDRESS HOMELESSNESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the coordinated 2 statewide homeless initiative provides important, cost-effective 3 homelessness prevention and rapid rehousing services statewide 4 and increases coordination through the statewide information and 5 referral system on behalf of homeless individuals and those at 6 risk of homelessness.

The coordinated statewide homeless initiative originated in 7 April 2016 to help hundreds of families escape or avoid 8 homelessness. According to Aloha United Way, since the program 9 10 began, the program has helped more than one thousand four hundred households comprising four thousand eight hundred 11 individuals. About three-guarters of households had been at 12 risk of losing housing and the rest were already homeless. Of 13 these numbers, sixty-four per cent included children. 14

Accordingly, the purpose of this Act is to appropriate moneys to continue and improve the coordinated statewide homeless initiative to prevent homelessness and rehouse homeless people in the State and to require the department of human 2018-2567 SB2027 CD1 SMA-1.doc
