

## A BILL FOR AN ACT

RELATING TO LEGISLATIVE HEARINGS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 21, Hawaii Revised Statutes, is amended
- 2 by adding a new part to be appropriately designated and to read
- 3 as follows:
- 4 "PART . COMMITTEE HEARINGS, GENERALLY
- 5 §21- Prerecorded video testimony; rules. Each chamber
- 6 of the legislature shall establish, by rule, procedures to
- 7 enable persons to present oral testimony at legislative
- 8 committee hearings through the use of prerecorded videos."
- 9 SECTION 2. Chapter 21 is amended by designating sections
- 10 21-1 to 21-19 as part I, entitled "Investigating Committees,
- 11 General Powers, and Duties of Sergeant-at-Arms".
- 12 SECTION 3. Section 21-1, Hawaii Revised Statutes, is
- 13 amended to read as follows:
- 14 "§21-1 Purpose. The purpose of this [chapter] part is to
- 15 establish procedures governing legislative investigating
- 16 committees to provide for the creation and operation of
- 17 legislative investigating committees in a manner [which] that

- 1 will enable them to perform properly the powers and duties
- 2 vested in them, including the conduct of hearings, in a fair and
- 3 impartial manner, consistent with protection of the
- 4 constitutional rights of persons called to testify at such
- 5 hearings and preservation of the public good."
- 6 SECTION 4. Section 21-2, Hawaii Revised Statutes, is
- 7 amended to read as follows:
- 8 "§21-2 Definitions. As used in this [chapter:] part:
- 9 "Hearing" means any meeting in the course of an
- 10 investigatory proceeding, other than a preliminary conference or
- 11 interview at which no testimony is taken under oath, conducted
- 12 by an investigating committee for the purpose of taking
- 13 testimony or receiving other evidence. A hearing may be open to
- 14 the public or closed to the public.
- "Investigating committee" means any of the following which
- 16 are authorized to compel the attendance and testimony of
- 17 witnesses or the production of books, records, papers, and
- 18 documents for the purpose of securing information on a specific
- 19 subject for the use of the legislature:
- 20 (1) A standing or special or select committee or committee
- of the whole of either house of the legislature;

1 A joint committee of both houses; (2) 2 An authorized subcommittee of a legislative committee; (3) 3 and Any body created by law, the members of which may 4 (4)include nonlegislators. 5 6 "Public hearing" means any hearing open to the public, or 7 the proceedings of which are made available to the public." 8 SECTION 5. Section 21-6, Hawaii Revised Statutes, is amended by amending subsection (c) to read as follows: 9 10 No action shall be taken by a committee at any meeting unless a quorum is present. The committee may act by a 11 majority vote of the members present and voting at a meeting at 12 which there is a quorum, unless the provisions of this [chapter] 13 14 part or any other statute require a greater number or 15 proportion." 16 SECTION 6. Section 21-13, Hawaii Revised Statutes, is **17** amended by amending subsection (c) to read as follows: "(c) Any person who appears before an investigating 18 committee pursuant to this section shall have all the rights, 19 privileges, and responsibilities of a witness provided by this 20

[chapter.] part."

- 1 SECTION 7. Section 21-15, Hawaii Revised Statutes, is
- 2 amended by amending subsections (a) and (b) to read as follows:
- 3 "(a) A person quilty of contempt under this [chapter] part
- 4 shall be fined not more than \$1,000 or imprisoned not more than
- 5 one year or both.
- 6 (b) If any investigating committee fails in any material
- 7 respect to comply with the requirements of this [chapter,] part,
- 8 any person subject to a subpoena or a subpoena duces tecum who
- 9 is injured by the failure shall be relieved of any requirement
- 10 to attend the hearing for which the subpoena was issued or, if
- 11 present, to testify or produce evidence therein; and the failure
- 12 shall be a complete defense in any proceeding against the person
- 13 for contempt or other punishment."
- 14 SECTION 8. Section 21-19, Hawaii Revised Statutes, is
- 15 amended to read as follows:
- 16 "§21-19 Limitations. Nothing contained in this [chapter]
- 17 part shall be construed to limit or prohibit the acquisition of
- 18 evidence or information by an investigating committee by any
- 19 lawful means not provided for herein."
- 20 SECTION 9. There is appropriated out of the general
- 21 revenues of the State of Hawaii the sum of \$ or so




- 1 much thereof as may be necessary for fiscal year 2017-2018 and
- 2 the same sum or so much thereof as may be necessary for fiscal
- 3 year 2018-2019 for the purpose of enabling persons to present
- 4 oral testimony at senate committee hearings through the use of
- 5 prerecorded videos.
- 6 The sums appropriated shall be expended by the senate for
- 7 the purposes of this Act.
- 8 SECTION 10. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$ or so
- 10 much thereof as may be necessary for fiscal year 2017-2018 and
- 11 the same sum or so much thereof as may be necessary for fiscal
- 12 year 2018-2019 for the purpose of enabling persons to present
- 13 oral testimony at house of representatives committee hearings
- 14 through the use of prerecorded videos.
- 15 The sums appropriated shall be expended by the house of
- 16 representatives for the purposes of this Act.
- 17 SECTION 11. Statutory material to be repealed is bracketed
- 18 and stricken. New statutory material is underscored.

1 SECTION 12. This Act shall take effect on July 1, 2017.
