A BILL FOR AN ACT

PROPOSING AMENDMENTS TO ARTICLES VII AND X OF THE CONSTITUTION OF THE STATE OF HAWAII TO AUTHORIZE THE LEGISLATURE TO ESTABLISH A SURCHARGE ON RESIDENTIAL INVESTMENT PROPERTY AND VISITOR ACCOMMODATIONS TO INCREASE FUNDING FOR PUBLIC EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that Hawaii's public
 schools are underfunded. Compared to school districts of
 similar size in other states, Hawaii ranks two hundred twenty seventh in per-pupil funding before adjusting for cost of
 living.

6 The legislature further finds that chronic underfunding of 7 public schools undermines the State's goal of providing a public 8 education to all of Hawaii's children. Specifically, 9 insufficient education funding results in delayed repairs to 10 school facilities; overheated classrooms; higher class sizes; a 11 lack of adequate classroom supplies; elimination of arts, 12 career, and technical education courses; budget cuts for special 13 education and English language learner programs; and an 14 increasing number of vacant teacher positions throughout the 15 State.

1	The purpose of this Act is to propose amendments to the
2	Constitution of the State of Hawaii to advance the State's goal
3	of providing public education for the children of Hawaii by
4	authorizing the legislature to establish a surcharge on
5	residential investment property and visitor accommodations.
6	SECTION 2. Article VII of the Constitution of the State of
7	Hawaii is amended by adding a new section to be appropriately
8	designated and to read as follows:
9	"SURCHARGE ON RESIDENTIAL INVESTMENT PROPERTY
10	Section . Notwithstanding any provision of this
11	constitution to the contrary, including Section 3 of Article
12	VIII, the State shall not be prohibited from establishing a
13	surcharge on residential investment property pursuant to Section
14	1 of Article X."
15	SECTION 3. Article X, section 1, of the Constitution of
16	the State of Hawaii is amended to read as follows:
17	"PUBLIC EDUCATION
18	Section 1. The State shall provide for the establishment,
19	support and control of a statewide system of public schools free
20	from sectarian control, a state university, public libraries and
21	such other educational institutions as may be deemed desirable,

1 including physical facilities therefor. There shall be no 2 discrimination in public educational institutions because of 3 race, religion, sex or ancestry; nor shall public funds be 4 appropriated for the support or benefit of any sectarian or 5 nonsectarian private educational institution, except that 6 proceeds of special purpose revenue bonds authorized or issued 7 under section 12 of Article VII may be appropriated to finance 8 or assist:

9 1. Not-for-profit corporations that provide early
10 childhood education and care facilities serving the general
11 public; and

12 2. Not-for-profit private nonsectarian and sectarian
13 elementary schools, secondary schools, colleges and
14 universities.

15 The legislature may establish, as provided by law, a
16 surcharge on residential investment property and visitor
17 accommodations to fund public education for all of Hawaii's
18 children."
19 SECTION 4. The question to be printed on the ballot shall

5	SECTION 5. New constitutional material is underscored.
6	SECTION 6. This amendment shall take effect upon
7	compliance with article XVII, section 3, of the Constitution of
8	the State of Hawaii
