# A BILL FOR AN ACT

RELATING TO HOUSING.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 107, Hawaii Revised Statutes, is		
2	amended by adding a new section to part II to be appropriately		
3	designated and to read as follows:		
4	"§107- Publicly funded residential housing; visitability		
5	standards. (a) In addition to the requirements set out in		
6	section 107-25, beginning January 1, 2019, the Hawaii state		
7	building codes may require that all new construction of publicly		
8	funded residential housing may incorporate housing visitability		
9	standards set forth by the International Code Council's		
10	Residential Building Code Type C Unit.		
11	(b) Nothing in this section may be construed to:		
12	(1) Place a financial or administrative burden on the		
13	operations or renovations of publicly funded		
14	residential housing;		
15	(2) Exceed the requirements for housing provided by the		
16	Americans with Disabilities Act of 1990;
