A BILL FOR AN ACT

RELATING TO MANUFACTURING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that there is a great

2 need for Hawaii to develop and support manufacturing in the

3 State. Over ninety per cent of the products the State consumes

4 each year are imported. At the same time, there is a great

5 demand outside the State for products that are made in Hawaii.

6 Nationally, revitalizing the manufacturing industry has been a

7 focal point for developing the United States economy as well as

8 a catalyst for innovation.

9 Hawaii manufacturers tend to be small, with thirty-four per

cent having less than four employees. These manufacturers only

provide four per cent of the manufacturing jobs in the State.

12 In contrast, five per cent of Hawaii manufacturers have more

13 than one hundred employees and provide thirty-seven per cent of

the manufacturing jobs in the State. To develop the industry,

Hawaii manufacturers will increasingly need to turn to advanced

manufacturing and industrial automation. Although automated

17 manufacturing reduces the number of workers required to produce

- 1 a product, it also provides local manufacturers the ability to
- 2 compete with offshore production. Ultimately, for many
- 3 products, Hawaii manufacturers cannot compete without
- 4 automation.
- 5 The legislature finds that Hawaii can identify its niche
- 6 and develop a viable manufacturing industry. The aloha shirt
- 7 and surf wear markets are just two examples of where Hawaii-made
- 8 products may have natural competitive advantages and command a
- 9 price premium. Presently, there is a limited supply of skilled
- 10 labor to produce these products, and the skilled labor force is
- 11 aging without a succeeding generation to continue the work.
- 12 Therefore, the legislature finds that an economic development
- 13 study on automated manufacturing opportunities is necessary to
- 14 support the manufacturing industry in Hawaii.
- 15 SECTION 2. The department of business, economic
- 16 development, and tourism shall conduct an economic development
- 17 study on opportunities for automated manufacturing in the State.
- 18 The department of business, economic development, and tourism
- 19 shall submit a report to the legislature with preliminary
- 20 findings and recommendations, including any proposed

- 1 legislation, no later than twenty days prior to the convening of
- 2 the regular session of 2019.
- 3 SECTION 3. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$150,000 or so much
- 5 thereof as may be necessary for fiscal year 2018-2019 for the
- 6 purpose of conducting an economic development study on
- 7 opportunities for automated manufacturing in the State.
- 8 The sum appropriated shall be expended by the department of
- 9 business, economic development, and tourism for the purposes of
- 10 this Act.
- 11 SECTION 4. This Act shall take effect on July 1, 2112.
