A BILL FOR AN ACT

RELATING TO HOMELESS INDIVIDUALS WITH SEVERE MENTAL ILLNESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the State has a gap 2 in services for homeless individuals with severe mental illness, 3 as these individuals often cycle between homelessness, emergency room treatment, incarceration, and hospitalization. Individuals 4 with severe mental illness typically become chronically homeless 5 and further burden the health care system through excessive use 6 of expensive emergency department, inpatient treatment, and 7 crisis services. Due to their mental illness, these individuals 8 9 routinely reject offered services and remain on the street, 10 putting themselves at risk of further injury and creating a 11 significant burden on the communities where they reside. 12 The State of Hawaii has always authorized the involuntary commitment of individuals to mental health services. However, 13 14 no mental health service providers in Hawaii currently provide 15 housing and services for individuals subject to non-forensic court-ordered involuntary commitment. - 2 directly place these individuals into housing and provide mental
- 3 health care services in a timely and impactful manner.
- 4 The purpose of this Act is to require the department of
- 5 human services, in consultation with the department of health,
- 6 to establish a pilot project to provide housing and mental
- 7 health treatment for homeless individuals with severe mental
- 8 illness who are subject to court-ordered involuntary
- 9 hospitalization pursuant to part IV of chapter 334, Hawaii
- 10 Revised Statutes.
- 11 SECTION 2. (a) The department of human services, in
- 12 consultation with the department of health, shall establish a
- 13 pilot project to operate a facility to provide shelter and
- 14 mental health treatment for homeless individuals with severe
- 15 mental illness who are subject to court-ordered involuntary
- 16 hospitalization to a psychiatric facility, pursuant to part IV
- 17 of chapter 334, Hawaii Revised Statutes, with the goal of
- 18 enabling these individuals to find permanent housing through
- 19 housing first programs.

- 1 (b) No more than ten severely mentally ill homeless
- 2 individuals may receive shelter and mental health treatment at
- 3 the facility at any given time.
- 4 (c) The department of human services shall use a suitable
- 5 unused state facility to provide shelter and mental health
- 6 treatment services; provided that the department shall make any
- 7 necessary changes to the facility to serve individuals with
- 8 severe mental illness.
- 9 (d) The pilot project shall end on June 30, . The
- 10 department of human services, in consultation with the
- 11 governor's coordinator on homelessness, shall submit a report
- 12 detailing findings and recommendations regarding the pilot
- 13 project, including findings regarding the pilot project's
- 14 contribution to successfully transitioning homeless individuals
- 15 with severe mental illness to permanent housing, challenges or
- 16 failures of the pilot project, and any proposed legislation, to
- 17 the legislature no later than twenty days prior to the convening
- 18 of the regular session of
- 19 (e) The department of human services may adopt rules
- 20 pursuant to chapter 91, Hawaii Revised Statutes, to effectuate
- 21 this Act.

- 1 SECTION 3. There is appropriated out of the general
- 2 revenues of the State of Hawaii the sum of \$ or so much
- 3 thereof as may be necessary for fiscal year 2018-2019 to
- 4 establish a pilot project to operate a facility, including
- 5 administrative expenses and any necessary renovations to the
- 6 facility, to provide shelter and mental health treatment for
- 7 homeless individuals with severe mental illness pursuant to this
- 8 Act.
- 9 The sum appropriated shall be expended by the department of
- 10 human services for the purposes of this Act.
- 11 SECTION 4. This Act shall take effect on July 1, 3000.
