A BILL FOR AN ACT

RELATING TO THE WEED AND SEED STRATEGY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The weed and seed strategy is a United States
- 2 Department of Justice initiative that is administered locally by
- 3 the United States Attorney's Office.
- 4 The weed and seed strategy is a collaborative effort among
- 5 federal, state, and county level law enforcement agencies,
- 6 social service agencies, private businesses, nonprofit
- 7 organizations, and residents to reclaim, restore, and rebuild
- 8 communities. The four key elements of the weed and seed
- 9 strategy are:
- 10 (1) Law enforcement;
- 11 (2) Community policing;
- 12 (3) Prevention, intervention, and treatment programs; and
- 13 (4) Neighborhood restoration.
- 14 The weed and seed strategy uses local law enforcement to
- 15 prevent, control, and reduce violent crime, drug abuse, and gang
- 16 activity in targeted neighborhoods by "weeding" out the criminal
- 17 element in the community. Community policing involves having

- 1 police officers work closely with community residents to develop
- 2 solutions to violent and drug-related crimes. The next step is
- 3 to "seed" the community with human services that include
- 4 prevention, intervention, treatment, and neighborhood
- 5 revitalization.
- 6 The legislature finds that the weed and seed strategy has
- 7 been successful since its inception in the Kalihi-Palama and
- 8 Chinatown areas of downtown Honolulu as well as in Waipahu and
- 9 Ewa/Ewa Beach. The legislature also finds that, since the
- 10 beginning of the program, crime in those areas has been
- 11 significantly reduced.
- 12 The purpose of this Act is to make an appropriation to
- 13 maintain the weed and seed strategy in those communities in
- 14 which the strategy is currently being implemented.
- 15 SECTION 2. There is appropriated out of the general
- 16 revenues of the State of Hawaii the sum of \$ or so much
- 17 thereof as may be necessary for fiscal year 2018-2019 to
- 18 maintain the weed and seed strategy.
- 19 The sum appropriated shall be expended by the department of
- 20 the attorney general for the purposes of this Act.

1 SECTION 3. This Act shall take effect on July 1, 2030.
